DISBURSEMENT OF THE FUND OF THE CREEK NATION.

SUBMITTING

A STATEMENT OF THE DISBURSEMENTS OF THE FUND OF THE CREEK NATION, AS PROVIDED BY THE ACT APPROVED JUNE 7, 1897.

May 25, 1898.—Referred to the Committee on Indian Affairs and ordered to be printed.

DEPARTMENT OF THE INTERIOR, Washington, May 24, 1898.

SIR: The Indian appropriation act approved June 7, 1897, contains the following provision:

Upon the properly authenticated demand of the Creek Nation, made after the passage of this act, the Secretary of the Interior shall, through an officer of the Government, disburse three hundred and thirty-three thousand dollars of the money in the Treasury of the United States belonging to the Creek Nation of Indians only for the payment of the debts of the government of the Creek Nation: Provided, That no debts shall be paid until by investigation the Secretary of the Interior shall be satisfied that said nation of Indians incurred said debt or issued its warrants representing the same for a full and valuable consideration, and that there was no fraud in connection with the incurring of said debt or the issue of warrants.

To the end that the Congress may be advised as to the action taken by the Department in this matter, I have the honor to transmit herewith the accompanying correspondence, showing the investigation made, as provided by the act, and the payments thereunder.

DEPARTMENT OF THE INTERIOR, Washington, February 3, 1898.

SIR. The act of June 7, 1897 (30 Stat. L., 68), directs the Secretary of the Interior to disburse, through an officer of the Government, the sum of \$333,000 of the money in the Treasury of the United States belonging to the Creek Nation, in payment of the debts of the government of the Creek Nation, after first satisfying himself by investigation

that said nation of Indians incurred said debts or issued its warrants representing the same for full and valuable consideration, and that there was no fraud in connection with the incurring of said debts or

the issuing of the warrants.

In compliance with this act, I have caused the indebtedness of the government of the Creek Nation to be investigated by Agent Dew M. Wisdom, of the Union Agency, Ind. T., and Special Inspector Zevely, and Assistant Attorney George C. Ross, of this Department, and herewith hand you their reports, dated September 7, 1897, November 2, 1897, and February 1, 1898, respectively, and their accompanying

papers.

From these reports it is found that of the list of the said warrants contained in Agent Wisdom's said report, aggregating \$208,941.08 payable from the general fund, and \$143,302.08 payable from the school fund, total \$352,243.16, certain warrants particularly described in the Zevely and Ross reports, amounting to \$11,150 of the general fund and \$74,580 of the school fund, are fraudulent; and that \$2,534.90 of the general fund and \$1,784.43 of the school fund, while not positively shown to be fraudulent, are considered doubtful; and that of the general fund \$3,443.85 and of the school fund \$211.75 have been paid. This leaves \$191,812.33 of the general fund and \$66,725.90 of the school fund, total \$258,538.23, which are found to have been regularly issued on bona fide indebtedness, and these amounts are now held, with few exceptions, by reputable business men, and recommendation is made in said report of Assistant Attorney Ross, dated the 1st instant, that they be paid.

Being satisfied from these investigations that the warrants last above alluded to, and described by number, name of drawee, and amount in the said report of Assistant Attorney Ross, dated February 1, 1898, on pages 11 to 41, both inclusive, amounting in the aggregate \$191,812.33 general fund and \$66,725.90 school fund, total \$258,538.23, represent indebtedness of said Creek Nation incurred for full and valuable consideration, and that there was no fraud in connection with the incurring of said indebtedness, or of the issuing of the said warrants, I have to request that you immediately take the proper steps to cause them to be paid by Agent Wisdom, of the Union Agency, Ind. T., first requiring him to give an approved bond in the sum of at least \$100,000 to cover deposits for such payment either in whole or by installments.

to cover deposits for such payment either in whole or by installments. I wish to say also that I desire that this payment shall be made with particular care, and in all respects according to the regulations of this Department and the best business methods, and that no warrants be paid except those enumerated on the pages of said report of Assistant Attorney Ross, above specified.

Instruct the agent to take the receipts of the payees, both on their respective warrants themselves and on his pay rolls, and to file the

warrants with his accounts.

When this payment is completed you will make full report thereof to this Department, together with copies (in duplicate) of said reports of Agent Wisdom, dated September 7, 1897, of Special Inspector Zevely, dated November 2, 1897, and of George C. Ross, dated February 1, 1898, with all important papers relating to the matter, for transmittal to Congress with my report of the investigation and payment.

SIR: I have the honor to transmit herewith, pursuant to your direction, the triplicate and quadruplicate copies of the cash account current, abstract of disbursements, and pay roll of the Creek warrant payment, made, pursuant to your directions of February 3, 1898, by Mr. Dew M. Wisdom, United States Indian agent, Indian Territory; also copies of the following papers: Report of United States Indian Agent Wisdom, dated April 14, 1898; instructions to Agent Wisdom, dated February 23, 1898; Department authority for payment, dated February 3, 1898; report of Special Inspector J. W. Zevely, with exhibits, dated November 2, 1897; and report of Assistant Attorney George C. Ross, dated February 1, 1898; also copies of such other papers as are essential to this report.

The cash account of the United States Indian agent shows that the total amount of money received by him for disbursement was \$258,538.23, and that this amount was disbursed as follows:

The unexpended balance of \$5,515.61 has been returned to the United States Treasury. The discrepancy of 51 cents between the outstanding warrants and the cash returned to the Treasury is fully explained by the balance sheets attached to the rolls.

It may be proper to state that account above referred to has been administratively examined by this office, found correct, and transmitted to the honorable the Auditor for the Interior Department, together with the paid and canceled warrants, for settlement.

All of the original papers pertaining to the Creek warrant payment are retained in this office for further use in the final settlement of the Indian agent's accounts.

Sir: I am in receipt of your letter of the 3d instant, transmitting a demand from the proper authorities of the Creek or Muscogee Nation of Indians, for the carrying into effect by the Secretary of the Interior of the provisions of the act of June 7, 1897 (Public No. 3, p. 7), relating to the disbursement, through an officer of the Government, the sum of \$333,000 of the money of said nation, "only for the payment of the debts of the government of the Creek Nation."

T., to make the investigation contemplated thereby, and to present his report in the case, with a schedule of the debts to be paid, and the necessary proofs to sustain the same, for the Department's action.

You are therefore directed to proceed with the examination without unnecessary

delay and to submit your report as early as practicable.

SIR: In reply to "Finance, 25015-97," of date July 8, 1897, I have the honor to inclose herewith a report of the Creek committee on warrants, covering a tabulated list of the same, which report, it will be seen, is approved by the principal chief of the Creek Nation, of date September 3, 1897, and which tabulated list is certified to by the said principal chief as showing that said warrants were issued by the Creek Nation for a full and valuable consideration, and that there was no fraud in connection with the incurring of said debts which said warrants represent severally, and that there was no fraud in connection with the issuance of said warrants.

It will be seen that said tabulated list represents the amount of \$352,243.16, which amount (according to the certificate of the chief) is a valid debt against the Creek

Nation.

It will therefore be seen the said amount of \$352,243.16 is in excess of the appropriation made by Congress to pay the indebtedness of the Creek Nation the sum of \$19,243.16, and therefore the appropriation, when exhausted, will still leave an out-

standing debt against the Creek Nation of \$19,243.16.

I am, however, informed officially that there is sufficient money in the treasury of the Creek Nation, arising from various sources of revenue, to discharge said excess. So far as I know or believe, the inclosed tabulated list has been prepared with great care, and I am satisfied that the several warrants embraced therein represent a bona fide or legitimate debt against said nation and that they should be paid, as far as possible, out of the appropriation made by Congress, to wit, \$333,000, and I therefore recommend that said sum be made available for that purpose under proper instructions from your office, after having been submitted to the honorable Secretary of the Interior for his approval.

[Extract from the acts and resolutions of the Cherokee National Council of the called session of August, and the regular session of October, 1896.]

COMMITTEE ON WARRANTS.

Whereas the Muscogee Nation desires to ascertain the accurate amount of its national indebtedness and prevent fraudulent manipulation of national warrants by changes on the face of said warrants from original to greater amounts; and

Whereas our national warrants are made of a very inferior article of paper and subject to changes as to value by the use of chemicals without detection; and

Whereas it is the desire of the Muscogee Nation to provide for the payment of its

just indebtedness; therefore,

SEC. 36. Be it enacted by the national council of the Muscogee Nation, That the principal chief be, and is hereby, authorized and directed to appoint a committee composed of three competent citizens who shall be charged with the duty of calling in all outstanding warrants, and to examine them thoroughly as to their correctness by comparing them with the stubs from which they were issued, and with the appropriations made therefor, and after such investigation has been completed a full report thereof shall be made to the principal chief, who shall take up and destroy said warrants found to be correct, and shall issue in lien thereof new warrants, in as large denominations as is practicable, to the holders of said old warrants.

The new warrants to be issued by the chief, as herein provided, shall be made of the best quality of bank paper, printed or lithographed, designed by private and appropriate designs, and stamped with a cut stamp showing the numerals of each

warrant.

Said committee shall provide an erasable stamp which shall contain the word "void," with which all fraudulent warrants presented shall be stamped or branded. Said warrants shall be returned to the holders thereof.

We have rejected \$27,000 spurious warrants which we branded "void" and returned

to the holders.

DEAR SIR: At the request of a well known and perfectly reliable citizen of the

Creek Nation this communication is addressed to you.

This party desires me to say to you that he is aware that a thorough investigation of Creek Nation warrants has been ordered by the Department, but he has every reason to believe that there are some very important features of this investigation that probably will be overlooked, to wit: The point where old Creek warrants are destroyed and new ones issued in their stead. He has every reason to know that the registering committee appointed by the Creek national council has placed their approval and "OK" upon a number of Creek warrants, for a consideration, that are rank forgeries and that there are United States citizens implicated in the crime.

He desires me to ask the Department as to what steps he should pursue to bring

these persons to justice.

He desires me to say to the Department that no investigation of Creek national warrants will be effective unless each and every one is investigated to its original owner, and the act of council authorizing its issue, as in his belief ten-dollar warrants have been made one hundred, or more, passed through the nation's officials, and a new warrant issued in its place for the raised amount.

He has every reason to know that warrants having no foundation in fact have been passed by this registering committee, a new warrant issued, and this new production

sold to some of the banks of the country at a discount.

SIR: Agreeably to instructions contained in your letter of September 15, 1897, and addressed to me at Helena, Mont, I repaired to Muskogee, Ind. T., to make an investigation of frauds reported to have been perpetrated in connection with the issuance of warrants for the payment of the indebtedness of the Creek government. On my arrival there I found Mr. George C. Ross, of the Assistant Attorney-General's Office of this Department, and together we conducted the investigation. In the first instance we ascertained that the committee that had been appointed in pursuance of the act of the Creek council, approved November 10, 1896, a copy of which is hereto attached (Exhibit I), had held its meetings at the town of Eufaula, and that they had there, at the time this investigation was begun, the stub books from which the old warrants from which they had passed had been issued. We found in their possession the following stub books:

December 5, 1887, to November 14, 1888, stubs from 12997 to 14016.

November 14, 1888, to January 21, 1890, stubs from 14017 to 15016.

February 9, 1890, to December 11, 1890, stubs from A1 to A1000.

January 8, 1891, to December 9, 1891, stubs from A1000 to A2000.

December 9, 1891, to December 17, 1892, stubs from A2001 to A3000 and 9 extra.

December 24, 1892, to November 6, 1893, stubs from A3001 to A4000.

October 28, 1893, to April 11, 1894, stubs from A4001 to A5010. May 13, 1894, to December 18, 1894, stubs from A5011 to A6000. December 18, 1894, to July 5, 1895, stubs from A6001 to A7000. November 28, 1895, to December 4, 1895, stubs from A7016 to A8000.

August 7, 1895, to September 13, 1895, stubs from A8001 to A9000. (In this latter book stubs from 8245 to 8316 are gone. In the stub book November 28, 1895, to December 4, 1895, stubs from A7016 to A8000, the stubs from A7001 to 7015, inclusive, are gone.)

December 9, 1895, to December 14, 1895, stubs from 8001 to 8250. December 18, 1895, to December 20, 1895, stubs from 8251 to 8500. December 16, 1895, to December 18, 1895, stubs from 8501 to 8750. December 14, 1895, to December 16, 1895, stubs from 8501 to 8750. December 30, 1895, to March 10, 1896, stubs from 9001 to 9250. October 29, 1896, to November 10, 1896, stubs from 1 to 250. November 7, 1896, to November 10, 1896, stubs from 251 to 500. November 10, 1896, to November 10, 1896, stubs from 501 to 750. November 10, 1896, to December 5, 1896, stubs from 751 to 1000. December 5, 1896, to January 14, 1887, stubs from 1001 to 1134. March 10, 1896, to June 10, 1896, stubs from 9251 to 9500. June 10, 1896, to August 29, 1896, stubs from 9501 to 9750. August 10, 1896, to October 29, 1896, stubs from 9751 to 10000.

From this it will be observed that the stub book from November 28, 1895, to December 4, 1895, purporting to contain stubs numbered from 7001 to 8000, inclusive, had torn from it stubs numbered from 1 to 15, inclusive, and that stub book from August 7, 1895, to September 13, 1895, purporting to contain the stubs and warrants from number A8001 to A9000 had torn from it stubs from 8245 to 8316. In connection with these missing stubs, I made an examination of the laws of the Creek Nation, and found that on pages 18 and 19 of the enactments of the sessions of May, June, October, November, and December, 1895, a resolution was passed by the Creek council directing the treasurer of the Creek Nation not to pay any warrants numbered from 8250 to 8316. Upon inquiry as to the occasion of the passage of this enactment, it developed that during the incumbency of Legus C. Perryman as principal chief of the Creek Nation, that the warrant book containing these warrants numbered from 8001 to 9000 was stolen from the principal chief, and that when the book was recovered a number of the warrants, stubs and all, had been stolen from the book, and this law was passed by the council to prevent any of these warrants,

if any should be issued, being paid.

In consequence of the act of the council, approved November 10, 1896, the principal chief, Isparhecher, appointed a committee of three citizens of the Creek Nation to conduct the investigation therein provided for. The persons appointed were Charles Gibson, James H. Crabtree, and George W. Stidham. Upon our visit to the committee at Eufaula we took an affidavit setting forth the manner of their procedure in the matter of investigating old warrants and directing the principal chief to issue new ones in lieu of those they found to be valid. Another provision of this act is to the effect that "after said investigation has been completed, a full report thereof shall be made to the principal chief, who shall take up and destroy said warrants found to be correct and shall issue in lieu thereof new warrants in as large denominations as is practicable to the holders of said warrants." Inquiry developed the fact that justead of this report being made in accordance with the provisions of this law—that is to say, when the work was all completed—the committee had reported, from time to time, as they had passed upon old warrants and had sent these old warrants with the reports to the principal chief, and when we arrived there all old warrants had been destroyed, thus rendering it impossible to check the stubs, with the old warrants. But it was found, upon inquiry, that, in many instances, when the holders of old warrants had presented them to this investigating committee for their action that they had at the time taken a descriptive receipt for the warrants left with the committee. We immediately learned, as far as was possible, the post-office addresses of the persons whom the report of Indian Agent Wisdom indicated as the holders of new warrants, and when it was impossible to see them in person addressed letters to them, requesting that they send us the receipts given them by the committee for the warrants submitted for examination.

In some instances our letters were returned as "Not called for," and in a few other instances we were unable to learn the whereabouts of persons indicated as holding warrants. In a good many others we received replies to the effect that they either had not taken any receipt from the committee at all or that when the new warrants were issued to them the receipts had been destroyed. In the case of the others they supplied us with the receipts they had given them by the committee. These receipts, in some instances, set forth the number of the old warrant, the person to whom it

was issued, for what amount, and the fund upon which it was issued. In others, they set forth, in addition to this, the date of the warrant, and in other cases they only set forth the number of the warrant and the amount and the fund upon which it was drawn. These amount to more than \$200,000, and these we were able to check up with the stub books, and found them, with now and then a slight discrepancy, to be correct. In the instances, where we had no receipts with which to check the stubs, the holders were usually found to be not business men, and had either never taken receipts or had destroyed them when they received their new warrants. Inquiry concerning these, made in a general way, elicited the fact, however, that they were honest men and very probably holding honest warrants.

A statement procured from the treasurer of the Creek Nation, C. B. Childers, shows, among other things, that the following warrants, which were reported by Agent Wisdom as due from the Creek government and to be paid out of the appropriation of \$333,000, have been paid by Treasurer Childers since they were issued by the investigating committee and he presented for our examination the warrants canceled

making a total of \$3,655.60 of valid warrants that have been paid by the treasurer since the report of the investigating committee to the principal chief, and hence not to be disbursed under the act of Congress of June 7. (See statement of Childers, Exhibit A)

At Okmulgee, the capital of the Creek Nation, we saw Chief Isparhecher and made an examination of the records found in his office touching upon these Creek warrants. We first got a statement that the principal chief can neither speak, read, write, or understand the English language (see his statement hereto attached), and that in the matter of the issuance of new warrants in lieu of the ones to be retired, he left the matter entirely to his secretaries, and that his private secretary, S. B. Callahan, had delegated the issuance of these warrants to his assistant, J. H. Lynch, and that Lynch had not only written ont every one of the warrants, but had signed both the names of the principal chief and the private secretary. (See Isparhecher's statement, Exhibit B.)

Our interviews with the principal chief were all conducted through an interpreter and Gen. Pleasant Porter, a citizen of the Creek Nation and chairman of the Creek commission to treat with the Dawes commission, was kind enough to act for us. The principal chief, upon request, directed his secretaries to place at our disposal all the records in his office, and here we found the "reports" of the Enfaula investigating committee upon the old warrants which they had reported to the principal chief as a valid and outstanding indebtedness against the Creek Government; and also had confirmed, by Secretary Lynch, the report that the old warrants had been destroyed. We took these "reports" and checked them up with the report of Indian Agent Wisdom to this Department, and found that in every instance the secretary to the principal chief had issued warrants in accordance with the reports made by the investigating committee to the principal chief. In other words, the sum total of these reports corresponded with the sum total of the report of Agent Wisdom, and, in the case of each individual holder of new warrants, the reports were found to tally with the report made by Wisdom to this Department.

In the examination of the reports of the investigating committee to the principal chief the fact was discovered that the committee had passed favorably upon a number of warrants numbered between the prescribed numbers of 8250 and 8316, and also a number of warrants numbered from 7000 to 7016, and that new warrants had been issued upon them. The warrants purporting to have been issued within these numbers were for large amounts, and the evidence shows they were all fraudulent. numbers were for large amounts, and the evidence shows they were all fraudulent. We found, for instance, old warrant No. 8315, dated October 10, 1894, for \$5,000 for "balance on survey issued to Surv. pastures," and No. 7008, dated July 7, 1894, for \$5,600, appropriated in 1893, for the support of N. Y. Sch., issued to the superintendent of N. Y. Sch.; No. 7007, dated February 17, 1895, for \$2,250 for support of Tallahassee school, in favor of T. W. Manuel; 7006, dated May 20, 1895, for \$2,250 for support of Wetumka school, in favor of William Robinson; No. 7005, dated April 15, 1895, for \$5,000 for building Euchee N. S., issued to the board of education. We ascertained who was the superintendent of the New Yuka school in the years 1893-94, and found it to be Prof. W. B. Robe. We sent for Mr. Robe and took his affidavit with reference to warrant No. 7008 for \$5,600. The substance of that affidavit is to the effect that there never was issued by the Creek Government a warrant for \$5,600 for the support of the school of which he was and still is the superintendent, but that the custom of the Creek Government had been to make quarterly payments to him for the support of his school of \$1,400; that in every instance he had collected these warrants himself, and that the warrant No. 7008, upon which this new warrant to F. M. Davis (181) for \$5,600 was issued, was a forgery and a fraud upon the Creek Government, and that the Creek Government does not owe any such sum, it having been paid to him long since. (The affidavit of Mr. Robe is marked Exhibit C. See also affidavit of F. M. Davis, Exhibit D.)

With reference to old warrant No. 8315, purporting to have been issued out of the fund for surveying pastures to pay the balance due for said work in the sum of \$5,000, the affidavit of W. L. Austin, who had surveying contract, to which is attached a statement by C. W. Turner, shows conclusively that said warrant was fraudulent in toto and had long prior thereto been paid by the Creek Government. Austin's affidavit is herewith filed, marked Exhibit E. (See also Davis's affidavit, Exhibit D.) Old warrant No. 7007 for \$2,250, and old warrant No. 7110 for \$4,700, old warrant 8301 for \$500, and old warrant 8302 for \$2,500, all purporting to have been issued to. T. W. Manuel as superintendent of Tallahassee school, are conclusively shown by the affidavits of T. W. Manuel and J. E. Turner, which are marked Exhibits F and G, to have been fraudulent and fraudulently issued warrants. Old warrants No. 7006 for \$2,250, and 8003 for \$2,500, and 8312 for \$3,000, purporting to have been issued in favor of William Robinson, superintendent of Wetunika school, for the support of said institution and for repairs upon the buildings, are conclusively shown by the affidavit of Mr. Robinson, hereto attached, to be fraudulent and fraudulently issued warrants. (Exhibit H.) Old warrant No. 7005 for \$5,000, and No. 8311 for \$4,500, purporting to have been issued in favor of the board of education for building Euchee school, are conclusively shown by the affidavit of C. W. Turner, hereto attached, marked Exhibit I, to be fraudulent and fraudulently issued warrants.

Old warrant No. 8296 for \$12,000 and old warrant No. 8297 for \$13,000, purporting to have been issued to J. M. Perryman (No. 8296 for building the Colored Orphan School and 8297 for building Eufaula High School), are conclusively shown by the affidavits of W. A. Maddin, marked Exhibit J, and C. S. Cobb, marked Exhibit K, to be fraudulent and fraudulently issued warrants. The affidavit of Mr. Perryman in connection with these warrants could not be taken, for the reason that Mr. Perryman is long since deceased. Old warrant No. 8306 for \$2,250, issued in favor of J. P. Davison for support of Pecan Creek school, is conclusively shown by affidavit of Davison, hereto attached (Exhibit L), to be a fraudulent and fraudulently issued warrant. Old warrant No. 8293 for \$750, in favor of S. B. Callahan (Exhibit M), for support of Wetumka school, is shown by his affidavit and the affidavits of J. H. Lynch and Samuel C. Davis to be a fraudulent and fraudulently issued warrant. Old warrant No. 8309, purporting to have been issued in favor of Taylor Chissoe for \$150 for salary as a member of the board of education, is conclusively shown by Chissoe's affidavit (Exhibit N) to be a fraudulent and fraudulently issued warrant. Old warrant No. 8111 purporting to have been issued to J. W. Mathis for \$80; old

Old warrant No. 8111 purporting to have been issued to J. W. Mathis for \$80; old warrant 7004 purporting to have been issued to N. G. Gregory for \$1,125; old warrant No. 8310 purporting to have been issued to D. M. Hodges for \$500; old warrant No. 8305 purporting to have been issued to Richard Bruner for \$275; old warrant No. 8308 purporting to have been issued to William Anderson for \$1,000; old warrant 8307 purporting to have been issued to J. M. Perryman for \$2,500; old warrant 8294 purporting to have been issued to L. C. Perryman for \$300; old warrant 8314 purporting to have been issued to "Creek commission to expel intruders," \$5,000; old warrant 8304 purporting to have been issued to the board of education for Eufaula

High School for \$6,000, and old warrant 8313 purporting to have been issued to the "B. of Ed. for colo. Or. Sch." for \$3,000, are all conclusively shown to be fraudulent and fraudulently issued warrants by the affidavits of J. H. Lynch and Samuel C. Davis, the latter of which is hereto attached and marked Exhibit O. In relation to the warrants last mentioned as being shown to be void by the affidavits of Lynch and Davis, some of the persons to whom they purported to have been issued were dead, others could not be found, and still others, notably D. M. Hodges and Rola McIntosh, refused to make statements (D. M. Hodges with reference to 8310 and Rola McIntosh with reference to 8314, he having been a member of the commission appointed to expel intruders). The affidavits of Lynch and Davis bear upon all the warrants, and should be taken into account in the consideration of every warrant, and are the only evidence as to some of them.

The fraudulency of all the foregoing warrants is established by indisputable

testimony.

In reference to those which follow, the only evidence touching them is the affidavit of J. H. Lynch, except No. 7015 for \$730, in connection with which should also be considered affidavit of S. C. Davis, concerning number and date; also, the fact that the stub from this warrant is missing from stub book. They are as follows: Old warrants Nos. 7960, 9631, 9628, 9629, 5707, 6327, 6331, 6523, 7536, 7821, 8831, 8834, 8870, 8879, 9645, 9956, 211, 291, 321, 113, 9842, making a total of \$1,360,06 issued in favor of R. E. Lynch; and old warrants Nos. 6973, 6975, 6980, 7015, 408, 409, 4010, 438, 441, 6781, 463, 8266, 450, 462, 512, 517, 518, 542, 546, 676, 678, 680, 698, 703, 711, 412, 8170, 8142, 8214, 8382, 8779, 8800, 8803, 8809, 8147, 8148, 7173, 7915, 7997, making a total of \$2,117.65 issued in favor of C. R. Reeder. In this last lot is old warrant No. 7015 in favor of P. Anderson for \$730. This warrant is one of those the stub of which was stolen from the warrant book. These two lists in favor of Reeder and Lynch, upon which the new warrants were issued, are doubtless fraudulent, as the statement of J. H. Lynch shows that they were issued upon the same terms as the other fraudulent warrants—namely, for a valuable consideration.

It is barely possible that these might be valid warrants, and if the holders of the new warrants issued in lieu of these are able to show conclusively that they are valid, then they ought to be paid. My opinion, however, is that they are fraudulent. In the affidavit of Mr. Lynch very grave suspicion is cast upon the validity of old warrants Nos. 5758 for \$500 and 5759 for \$500, upon which new warrant No. 423, in favor of the First National Bank of Muscogee, was issued for \$1,000. My opinion is that Mr. Lynch is mistaken in his conclusion about this warrant, and that the new warrant issued in lieu of these old ones ought to be paid. Mr. Ross fully concurs in this opinion. In support of this theory, the affidavit of C. H. Warth is hereto

attached, marked Exhibit P.

Old warrant No. 5823, dated November 3, 1894, issued to S. Davis for "Cancellation of ct. certificate" for \$841.62, directed by the committee to be issued to the Muscogee Bank, and upon which new warrant No. 416 in favor of the First National Bank of Muscogee has been issued for \$841.62 is a doubtful warrant. J. H. Lynch, the secretary to the principal chief, is uncertain about this warrant. The bank ought to be given an opportunity to show, if it can, that this is a valid warrant.

The statement of Ellis B. Childers (Exhibit A) is filed herewith not only for the purpose of showing his connection with the issuance of these bogus warrants, but his misstatements as to the funds of the Creek Government in his hands. It will be observed that he reports, in addition to the money in the subtreasury at St. Louis, to have about \$5,000 on deposit at the First National Bank at Muscogee and about \$5,000 at the First National Bank at Wagoner. The cashier of the First National Bank at Muscogee, upon examination of his books, found that Mr. Childers had no deposit in said bank to his credit as treasurer, and only a small balance, much less than \$5,000, to his individual account. The statement of Mr. J. W. Wallace, cashier of the First National Bank at Wagoner (Exhibit Q), is herewith filed to show Childers's misstatement in reference to his claim in that bank. It will also be observed from Childers's statement that he claimed to have some \$4,000 of Creek warrants on deposit with E. E. Baldridge, of Wagoner, as collateral. The affidavit of Mr. Baldridge (Exhibit R) is herewith filed, showing that Mr. Childers had no warrants deposited with him as collateral, but that Childers did have deposited with him as collateral \$7,500 in cash.

The affidavit of Baldridge also shows that Childers, in the course of a cattle deal with him, gave him in payment a check on the subtreasury at St. Louis for \$2,500. Childers, in his statement, shows that he bought warrants from the Jones Mercantile Company and from H. F. Jones individually. The affidavit of H. F. Jones (Exhibit S) and the affidavit of M. F. Davis (Exhibit D) are herewith filed to show Childers's connection with the issuance of fraudulent warrants and to show that these gentlemen, who were reputable merchants of the Territory, lent themselves to, if they did not

participate in, the conspiracy to defraud the Creek Government; and further to show fraudulent character of warrants issued in their names at Childers's instance. The affidavits of the commissioners appointed on behalf of the Creek Government to treat with the Dawes Commission (Exhibit T) is herewith filed for the purpose of showing what probably occasioned Treasurer Childers to admit the payment of the new warrants heretofore mentioned and to cancel them.

The affidavit of T. E. Smiley (Exhibit U) in whose name were issued some \$15,130 of the new warrants is herewith filed for the purpose of showing the connection of Burril Cox with this transaction, and also for the purpose of illustrating the method of procedure on the part of the conspirators. The affidavit of Samuel C. Davis (Exhibit O), who was private secretary to Principal Chief L. E. Perryman from the latter part of 1892 until Chief Perryman was deposed in 1895, is filed herewith for the purpose of showing that the warrant book containing warrants numbered from 8001 to 9000 was, at one time, gotten away from Chief Perryman by one Ed. Egan, and that when it was returned quite a number of the warrants, stubs, and all, had been abstracted from said book; that subsequently James Eagan and Burril Cox requested Chief Perryman to give them an order upon Ed. Egan for these stolen warrants; that the chief at first refused to do so, but finally, upon their promise to pay him \$5,000, gave them the order for the warrants. These warrants seem to be the ones which were used for presentation to the investigating committee upon which the fraudulent issue is based. These old warrants that are numbered between 8245 and 8319 are all dated in 1892, 1893, and 1894. The affidavit of Davis shows that this warrant book was not purchased until 1895, and hence that it would be impossible that valid warrants bearing those numbers and dates could have been issued. His affidavit corroborates in toto the affidavit of J. H. Lynch.

The affidavits of Charles Gibson (Exhibits V and W) are herewith filed for the purpose of showing the manner of procedure on the part of the committee in investigating the character of the old warrants and in certifying to the principal chief those that were valid for reissue. It will be observed from his statement that he says that all of the old warrants passed through his individual hands; that whilst they were making this investigation Crabtree examined the stub books and Stidham examined the appropriation books. He (Gibson) would read the number and date of warrants, to whom issued, for what purpose, amount, and from what fund; that Crabtree would then examine the stub book, and, if he found the stub to correspond, would so report; that Stidham would then examine the appropriation book, and if he found the appropriation he would so report, and the warrant would then be passed upon as valid and sent to the principal chief for reissue; that in no instance did he sanction the certification to the principal chief of any warrant which had not stood this test. He further says that the reports which they made to the principal chief were, in every instance, an accurate description of the old warrants upon which they

had passed.

The affidavit of Bunnie McIntosh (Exhibit X) is herewith filed, showing the cor-

rupt disposition of the investigating committee.

There is also herewith filed verbatim copies of the report, made to the principal chief, which are involved in this controversy. These reports formed the basis of our investigation, and without them I fancy we would have been unable to secure evidence of these frauds, as there was no other possible means of running down suspicious warrants, as the new warrants, in themselves, do not in any manner indicate what warrants they are issued in lieu of. (These reports are marked Exhibit Z.)

The affidavit of J. H. Lynch, marked (Exhibit Y) is herewith filed for the purpose

of showing the corrupt methods employed by Childers, the treasurer of the Creek Nation, and Crabtree and Stidham, members of the investigating committee, and their associates in issuing and uttering false and fraudulent warrants shown by this report to be such. The statements of Crabtree and Stidham were not taken because their complicity in the corrupt issuance of these warrants was clearly demonstrated, and Gibson's statement as acting chairman of the committee covered all the points that were needed with reference to the manner of their conducting their investigation.

Some of the descriptive receipts which were sent to us for the purpose of enabling us to cheek up with the stub book were left with us and are herewith filed for

information.

Those who supplied us with receipts for all the warrants they had presented to the investigating committee for their action were W.C. Trent, First National Bank at Muscogee, Spalding & Co., W.E. Gentry & Co., J. E. Turner & Co., T. F. Meagher, F. B. Severs, James Parkinson, First National Bank at Wagoner, Hutchins and English, C. W. Turner, Foley & Tulley, C. E. Foley, P. K. Morton, Patterson & Co., Brown Bros., Leo E. Bennett, Burdett Hardware Co., C. W. Garrett, and Mrs. J. M. With the aid of these receipts we checked up all of the old warrants Perryman. and found the stubs to agree with the descriptive receipts.

In making the disbursement under the provisions of the act of Congress of June 7 the following new warrants ought not to be paid, because they have already been paid:

The following new warrants, in my opinion, are also fraudulent. Mr. Ross is in very grave doubt about them, and we agree in thinking that the money ought not by any means to be disbursed, but that the holders of the new warrants should be given an apportunity, if they can, to show that the warrants are based upon a valid claim.

Under J. H. Lynch's statement, new general warrant No. 423 in favor of the First National Bank of Muscogee for \$1,000, ought not to be paid, but under Cashier Warth's affidavit (Exhibit P) explaining the connection of the bank with this warrant, Mr. Ross agrees with me in thinking the warrant ought to be paid.

In relation to new warrant No. 416, issued to the First National Bank of Muscogee

for \$841.62, based upon old warrant No. 5823 in favor of S. Davis for \$841.62, Lynch, who issued the new warrant, was uncertain as to whether or not this was a valid debt of the Creek Government. In this view of the case the money ought not to be disbursed until the present holders of the warrant can give satisfactory proof of its validity

There is also filed herewith the letters of persons who had either not taken or lost or destroyed their receipts, and also return letters which were addressed to persons

asking for their receipts.

It will thus be seen that the report of Indian Agent Wisdom, dated Muscogee, Ind. T., September 7, 1897, inclosing the report of the Creek committee, approved by the principal chief, by which report the valid debt of the Creek Government appears to be \$352,243.16, is erroneous to the extent of the warrants above enumerated, amounting to \$93,704.93 out of said sum, which certainly ought not to be paid.

Wherever the words "new warrants" have been used in this report reference is had to the warrants set forth in the report of Agent Wisdom to this Department, of

September 7, 1897.

The paper's touching on this case sent to us by the honorable Commissioner of Indian Affairs are herewith returned, and that part of Indian Agent Wisdom's report which purports to set forth the outstanding indebtedness of the Creek Nation, giving the names of the persons holding new warrants, together with the number and amounts of said warrants, will be necessary and essential, in connection with this

report, to the officer who disburses this money.

In conclusion, in the matter of paying the new warrants concerning which no testimony casting doubt upon them has been received, I know of no means, beyond what has already been employed, of determining as to whether or not frauds have been committed in connection with their issue. In those cases where receipts were given by the committee to persons presenting old warrants they have been checked up and found substantially to correspond with the stubs from which they purported to have been issued.

In those instances where people either did not take receipts at all, or have since destroyed them, I know of no means that will enable one to check them up with

the stubs.

Many of these warrants are held by merchants, business men, and farmers in the Territory, and they represented to us that they were sorely in need of the money, as, in many instances, they had been carrying these warrants for long periods.

Attached hereto, marked Exhibit A1, is a list of the names of the persons implicated in this conspiracy and the names of others who, if they did not participate in the contemplation of it, at least lent themselves to its execution.

All of which we beg leave to submit.

Sir: Under the act of Congress approved June 7, 1897, entitled "An act making appropriation for the current and contingent expenses of the Indian Department,

etc. (30 Stat., 68), it is provided that

"Upon the properly authenticated demand of the Creek Nation made after the passage of this act the Secretary of the Interior shall, through an officer of the Government, disburse three hundred and thirty-three thousand dollars of the money in the Treasury of the United States belonging to the Creek Nation of Indians, only for the payment of the debts of the government of the Creek Nation: Provided, That no debts shall be paid until by investigation the Secretary of the Interior shall be satisfied that the said nation of Indians incurred said debt or issued its warrants representing the same for a full and valuable consideration and that there was no fraud in connection with the incurring of said debt or the issue of warrants."

In pursuance of this act, Isparhecher, principal chief of the Creek or Muscogee Nation, on June 29, 1897, made a demand upon the Secretary of the Interior for a disbursement, through an officer of the Government, of \$333,000 of the mouey in the

Treasury of the United States belonging to the Creek Nation of Indians.

Under instructions from this Department, the Commissioner of Indian Affairs, on July 8, 1897, directed Dew M. Wisdom, United States Indian agent, Union Agency, Ind. T., to make the investigation contemplated in the act.

In pursuance of this order, on September 7, 1897, Agent Wisdom submitted the "report of the Creek committee on warrants." This report purported to exhibit the

outstanding indebtedness of the nation as shown by the warrants issued, to whom issued, in what amounts, their serial numbers, and from what fund to be paid-i.e., general or school fund.

By this report it was shown that the indebtedness of the nation to be

Total indebtedness....

Accompanying the report of the "examining committee" was the certificate of Isparhecher, the principal chief, stating "that said warrants were issued by the Creek Nation for a full and valuable consideration, and that there was no fraud in connection with the incurring of said debts which said warrants represent, severally, and that there was no fraud in connection with the issuance of said warrants."

This certificate concluded with a recommendation that the warrants be paid to the individuals holding the same. The certificate bears the name also of S. B. Callahan,

private secretary.

In submitting the report of the examining committee on Creek warrants, and the

certificate of the chief as to the genuineness of said warrants, Agent Wisdom says:
"So far as I know or believe the inclosed tabulated list has been prepared with great care, and I am satisfied that the several warrants embraced therein represent a bona fide or legitimate debt against said nation, and that they should be paid, as far as possible, out of the appropriation made by Congress, to wit, \$333,000, and I therefore recommend that said sum be made available for that purpose under proper instructions from your office after having been submitted to the honorable Secretary of the Interior for his approval."

This report shows on its face that Agent Wisdom did not make an independent investigation of the validity or genuineness of the warrants, but accepted the report of the committee and the certificate of the principal chief as evidence that the war-

rants were all issued for a full and valuable consideration.

It appearing to the Department that the investigation completed by the act had not been made, and from certain information obtained from reputable sources that there were some indications of fraud in connection with the issuance of said warants, in October, 1897, J. W. Zevely, special inspector for this Department, and myself, were directed to make the investigation contemplated by the act.

A report of that investigation, prepared by Mr. Zevely and signed by both himself and me, was filed in the Department November 2, 1897. This report contains copies of the affidavit that we took, and our entire methods of procedure in arriving at the

conclusions reached and the recommendations submitted.

We found indubitable proofs of fraud in connection with the issuance of certain warrants, which the report indentifies by the serial numbers, amounts, and persons to whom issued.

We discovered the perpetrators of the frauds, and under directions gave their names to the district attorney for the northern judicial district of the Indian Territory, together with the evidence upon which they were severally indicted by the grand jury.

These fraudulent warrants were by number, name, and amount designated in our report, which fully illustrated and explained the methods by which the frauds were consummated, and which was accompanied by exhibits and affidavits fully justifying our recommendation that such fraudulent warrants be not paid.

We also reported another list, which, while containing certain features more or less suspicious, we were not prepared to report upon as absolutely fraudulent, and we recommended that the holders of the warrants described in that list be permitted to offer further proof of their genuineness and overcome the slight evidence obtained by us of their fraudulent character.

As to the residue of the warrants not described in the three foregoing lists, we found that they had been regularly issued. We sought all possible means to be able to report upon them. We found no evidence whatever to prove that any one of the warrants was spurious. As before reported, the old warrants upon which the new warrants were based have been destroyed. These old warrants had in many cases passed from hand to hand as a circulating medium without indorsement. They were generally held by reputable merchants and traders, who had obtained them in due course of business and had sent them to the Creek examining committee with directions to issue new warrants in larger denominations.

Those old warrants had been given for sundry services, as for teachers' salaries,

school supplies, judges' salaries, per diem for councilmen, light-house service, etc. Mr. Zevely, in his recent report, in speaking of the impracticability of absolutely proving the genuineness of these old warrants, says:

"The persons who surrendered them to the examining committee at Eufaula could not now trace them. The most they could do would be to make affidavits setting forth their belief that they were good."

He says, after making further investigation, "I think all those reported valid are valid."

All the warrants, both good and bad, having been issued under the forms of the Creek law and by officers duly authorized to issue them, are prima facie valid.

The presumption of their validity is only overcome by the production of testimony strong enough and conclusive enough to overcome that presumption. This character of testimony was obtained as to the list above written, but as to the list hereinafter made we could find no testimony which in the least would serve to east suspicion upon their validity.

With a few exceptions, the warrants hereinafter described are held by reputable business men. Many of the holders did all they could to aid us in discovering the fraudulent warrants, and some of them said that they would prefer to lose their holdings in warrants rather than see the conspirators who sought to rob the nation profit by their fraudulent acts.

In consideration of the above views I earnestly recommend that the warrants, a

list of which is below given, be paid. The requirement of Congress, namely: "That no debts shall be paid until by investigation the Secretary of the Interior shall be satisfied that said nation of Indians incurred said debt or issued its warrants represausned that said nation of Indians incurred said debt or issued its warrants representing the same for a full and valuable consideration, and that there was no fraud in connection with the incurring of said debt or the issue of warrants," has been fully met when we, as your representatives, found nothing whatever to overcome the prima facie evidence as to the validity of the warrants which we unite in saying should be paid under the terms of the statute above quoted.

EXHIBIT 1.

COMMITTEE ON WARRANTS.

Whereas the Muskogee Nation desires to ascertain the accurate amount of its national indebtedness and prevent fraudulent manipulation of national warrants by changes on the face of said warrants from the original to greater amounts; and

Whereas our national warrants are made of a very inferior article of paper and subject to changes as to value by the use of chemicals without detection; and

Whereas it is the desire of the Muskogee Nation to provide for the payment of its just indebtedness: Therefore,

Sec. 36. Be it enacted by the national council of the Muskogee Nation, That the principal chief be, and is hereby, authorized and directed to appoint a committee composed of three competent citizens, who shall be charged with the duty of calling in all outstanding warrants and to examine them thoroughly as to their correctness by comparing them with the stubs from which they were issued and with the appropriations made therefor, and after such investigation has been completed a full report thereof shall be made to the principal chief, who shall take up and destroy said warrants found to be correct and shall issue in lieu thereof new warrants, in as large denominations as is practicable, to the holders of said old warrants.

The new warrants to be issued by the chief, as herein provided, shall be made of the best quality of bank paper, printed or lithographed, designated by private and appropriate designs, and stamped with a cut stamp showing the numerals of each warrant. Said committee shall provide an erasable stamp which shall contain the word "void," with which all fraudulent warrants presented shall be stamped or

branded. Said warrants shall be returned to the holders thereof. Sec. 37. Be it further enacted, That the national treasurer be, and he is hereby,

directed to not pay only on the warrants that are herein provided for.

SEC. 38. Be it further enacted, That said committee shall receive a per diem of five (\$5.00) dollars per day each for the time of their actual service.

SEC. 39. Be it further enacted, That the sum of one thousand (\$1,000.00) dollars be, and is hereby, appropriated in favor of the principal chief, to be by him used for paying the per diem of said committee and such other expenses as shall be necessary to carry this act into effect.

SEC. 40. Be it further enacted, That the new warrants herein provided for shall consist of two classes. One class shall be drawn on the school fund and the other on the general fund, neither of which class shall be payable by the national treasurer until indorsed by the national auditor and by the holder thereof.

Sec. 41. Be it further enacted, That all acts or parts of acts in conflict herewith

are hereby repealed.

The above warrants have been paid and canceled by me and are not outstanding against the Creek Government. These are all of the new warrants that have been paid.

The report of the debt of the nation at the time I went into office I sent to Creek delegates for the information of the committee at Washington—a general report, not

a detailed one at all.

At one time I had a little over \$12,000 in warrants. I began buying warrants this year. I bought warrants from Dick Bruner (P. O., Coweta) first between \$200 and \$300. Bought some from Annie Cox, about \$80.00; bought little over \$2,100 from F. M. Davis, F. M. Davis and J. A. Harris made purchases for me. Don't know anything about warrants Mr. Davis has; don't know anything about warrants Harris has. I now have on hand a little over \$3,000. Some up as collateral at Bank of Wagoner. Sold Warth \$8,000 or \$9,000 worth. Presented some warrants, large ones, to committee, but don't remember what they were. Think I have a memorandum of all this at home. The warrants I bought I had issued to J. A. Harris and H. F. Jones, both of Wagoner; old warrants Nos. 8313, bd. of ed. Col. Orph. School, Apl. 6, 1895, for \$3,000, and 8312, Jan. 10, 1895, issued to bd. of education for repairs Wetumka School for \$3,000.00, were mine, and I had them issued to J. A. Harris.

These I have disposed of; don't know who holds them. Think I got these from "Lawrence County Bank," of Missouri. Don't know whom they got them from. Don't know anything about U. B. Gray or his warrants; never bought from or sold to Gray; know T. E. Smiley; never traded in warrants with him; know James Egan; bought a few small warrants from him, and don't know anything about his warrants. I bought all the warrants of the Jones Mercantile Co. and of H. F. Jones individually. I think I bought warrant No. 8311 of R. E. Lynch, of Tulsa, and had new warrant issued to H. F. Jones; No. 7010, I think I bought from Jones—am not sure. Think I bought Jones Mercantile Co. warrants after the new warrants were issued. C. W. Turner and I aided each other in handling a good many warrants; don't know numbers or amounts; I am 32 years old. Have been stock farmer, and am Made most of my money in pasture leases. Have had leases for 9 years. I had about \$9,500 voided; have most of these warrants at home now, I think. Left some of my warrants with Warth and some with Baldridge at Wagoner. I now have with Baldridge, as collateral, about \$4,000. With Warth I put \$14,000; sold \$11,000 of these through Warth. Put with Warth second time about \$15,000.00. Warth now has about \$18,000 of my warrants as collateral or for sale. Think Warth sold the Has about \$15,000 of my warrants as contactal or for said. Think wards sont the \$1,100.00 to K. C. bankers. In St. Louis at subtreasury to credit of Creek Nation I now have seventy odd thousand dollars. I have about \$8,000 with Foley—Creek Government funds; about \$5,000 at First National Bank at Wagoner, and about \$5,000 with First National Bank at Muscogee, and \$2,468 in the safe of the nation here. I know nothing about any other warrants.

EXHIBIT B.

OKMULGEE, IND. T., October 6, 1897.

I, Isparhecher, principal chief of the Muskogee or Creek Nation, desire that a careful examination be made of the outstanding indebtedness of the nation that has been passed upon of the examining committee, Messrs. Crabtree, Stidham, and Gibson. The committee composed of these gentlemen citizens was appointed by me in pursuance of an act of the council providing for an examination into all of the outstanding indebtedness of the nation and certify the same to me, that new warrants for the whole amount might be issued to the people who have just claims.

The report of the committee was first sent to the executive office unsigned by the committee, and I directed it to be returned and properly signed by the committee,

attesting the true indebtedness.

I depended entirely on the committee to make an honest report, and my secretary, J. H. Lynch, issued new warrants for the amount certified by said committee to be

due to the several old warrant holders.

I have recently heard that new warrants have been issued by Lynch on the report of said committee, and that some of these warrants were wrongfully issued, the debt represented by them having either already been paid or warrants fraudulently issued. I have no official information that such illegal warrants have been issued, but certain facts which have recently been communicated to me make me fear that such is the case. I will be thankful to Messrs. J. W. Zevely and George C. Ross, United States Government officers, if they will, in pursuance of their directions from the Secretary of the Interior, ascertain what new warrants have been fraudulently issued, in order that payments thereof may be prevented.

It is my carnest desire to see that only just warrants are paid and all fraudulent ones be canceled, and that the perpetrators of the frauds, if any, be properly punished. I will further state that I can not read, write, or speak the English language, and I depended entirely upon my secretaries, S. B. Callahau and J. H. Lynch, to

properly attend to the duties in issuing all new warrants.

W. B. Robe, being duly sworn, deposes and says that he is now and has been continuously since November, 1892, superintendent of the Nuyaka Indian Boarding School; that as such superintendent he has disbursed all appropriations that have been made by the Creek council for the benefit of said school; that in the year 1894

there was appropriated by said Creek Nation for said school the sum of \$5,600; that the said sum was issued to him by the principal chief in four warrants for \$1,400 each, dated, respectively, January 16, May 19, August 8, and October 26; that the appropriations for 1893 were also disbursed by him, and that the appropriation for this year amounted to only \$5,040, and that warrants were issued to him for said amount as follows: March 1, \$1,400; May 5, \$840; July 19, \$1,400, and November 3, \$1,400.

Deponent further says that "old" warrant No. 7008, dated July 7, 1894, purporting to have been drawn in favor of "Supt. N. Y. Sch.," for the "Suppt. N. Y. Sch.," is a fraudulent warrant, and that the appropriations for the years 1893 and 1894 were drawn by him on warrants issued by the principal chief out of the treasury of the Creek government, and that the Creek government does not now owe such sum or any part of such sum. That old warrant No. 7008, purporting to have been issued to me, as said superintendent, and approved as valid by the examining committee, consisting of Messrs. Gibson, Crabtree, and Stidham, and certified to the principal chief with direction to issue new warrant to F. M. Davis, of Wagoner, for said amount, is a fraud upon the Creek Nation, and said new warrant should not have been issued, as said sum is not due from it to F. M. Davis or anybody else on account of said warrant above mentioned.

EXHIBIT D.

F. M. Davis, being duly sworn, upon his oath says: That up to January, 1897, he was a member of the mercantile firm of Davis-Jones Mercantile Company, of Wagoner, Ind. T. That after he had gone out of the firm, and in April of this year, he took to the committee at Eufaula the old warrants of the firm for Mr. Jones and presented them to the committee for examination; these were the old warrants upon which were issued the new warrants, general No. 329 for \$1,387.10 and school No. 135 for \$827.70, making a total of \$2,214.80. In addition to these my recollection is that at the same time I presented to the committee old general fund warrants amounting to about \$132 and one "old" school warrant of about \$750, but these I sold to Foley and Tulley after I had filed them. The new warrants for the warrants sold Foley and Tulley were never sent to me by the principal chief, and I presumed were sent to Foley and Tulley.

Early this summer Mr. E. B. Childers, treasurer Creek Nation, came to me and said that he was dealing in warrants and already had some in hand, and that he was going to have them issued in my name. The reason that he assigned for this was that he had several warrants for collection and that it would prevent complications. As Mr. Childers had been a friend of mine I gave my consent, and when he brought warrants to me for my indorsement I indorsed them. I presume he presented them to the committee himself. I am sure I never presented them. I have not now, and never had, any interest in the Isparhecher warrants of the following numbers and amounts: No. 402, general fund, \$5,000; and the following numbers school warrants: 159, \$1,000; 160, \$1,000; 161, \$1,000; 162, \$500; 163, \$500; 165, \$3,000; 166, \$1,750; 181, \$5,600, which are now outstanding and reported to the Commissioner of Indian Affairs as due from the Muskogee government.

I know nothing of these warrants, and do not know where Mr. Childers got them

or any of them.

Some time in 1886 we had on hand warrants amounting to something over \$2,000, mostly school warrants. We needed some money and I went to Mr. Childers and asked him if he could not give us a check for the amount and take the warrants and hold them until next pro rata payment was made. He said he would, and did give us check for amount, and he now holds said warrants, as no disbursement has since been made, and these warrants may now compose a part of the warrants Mr. Childers holds, and probably do.

SOUTH MCALESTER, IND. T., October 14, 1897.

W. L. Austin, of South McAlester, Ind. T., being duly sworn, on his oath says: That in pursuance of an act of the Creek council of the Indian Territory L. C. Per-

ryman, then chief of said nation, appointed him to survey pastures in the Creek Nation, the appointment being made about November, 1892; that he thereupon entered upon said duties and finished the work of survey about July, 1893; that from time to time, as the work of survey proceeded, he received from the chief of the nation, the said Perryman, warrants covering the pay for the work completed; that after he had completed the work and reported to the said chief he received warrants for the full amount due him.

That all of the warrants he received he turned over to C. W. Turner, of Muskogee, Ind. T., and the said Turner informed the affiant that he had received from the treasurer of the nation the full amount of money due upon said warrants so issued to him; that the survey so made by him was the only survey that was ever made, either before or since, at the instance and under the authority of the Creek Nation; that he has resided in said Territory since the spring of 1873; that warrant No. 8315, dated October 10, 1894, for \$5,000, alleged to have been issued for balance on survey, has no proper foundation, for the reason that there was no balance for said survey left unpaid by the nation; that no warrants for the sum of \$5,000 were ever issued for said work, all being for smaller amounts. I am therefore positive that said warrant No. 8315 was fraudulently issued.

EXHIBIT F.

T. W. Manuel, being duly sworn, upon his oath says: That he is a citizen of the Creek government, about 35 years old, and lives at Coweta Court-House, Ind. T. Says that he was appointed superintendent of the Tallahassee Mission School in August, 1891, and held said position continuously until August, 1894. During the three scholastic years that I was superintendent of said school J. E. Turner negotiated all of my warrants for the support of the school. One warrant for \$2,500 I got myself from the chief and turned over immediately to J. E. Turner. For all the others I gave J. E. Turner an order on the chief, and never even saw them. The warrant No. 7007, passed upon by Eufaula committee, dated March 17, 1895, payable to me for support of Tallahassee Mission, for \$2,250, was never issued to me, for I was not at that time superintendent of said mission, having gone out the previous August. Said warrant must be fraudulent. Warrants Nos. 8301 and 8302, presented to the investigating committee and favorably passed upon by them, 8301 for \$500 and 8302 for \$2,500, as belonging to James Egan, must have been fraudulent, because my warrants were all given to Mr. Turner, and because there never was a warrant for \$500 issued to me during my tenure, and Mr. Turner has either had the warrants cashed by the Creek treasurer or still holds them.

Manuel was superintendent of Tallahassee Mission School he turned over to said Turner every warrant that was issued to him (Manuel) for support of said school; that said warrants, all of them, were duly presented to the treasurer of the Greek government

for payment, and that they have all been paid, and that the Greek government does not now owe a cent on account of the support of said mission during the time Manuel was superintendent. Deponent further says that Manuel's connection with said school was severed in August, 1894.

He says that there was never issued to him during his term as superintendent a warrant for the sum of \$2,250; that the old warrant, No. 7006, dated May 20, 1895, purporting to have been issued to him, which was presented to the examining committee, consisting of Messrs. Gibson, Crabtree, and Stidham, and passed as valid and upon which the principal chief was directed to issue a new warrant for same to F. M. Davis for the sum of \$2,250, is, to the best of his knowledge and belief, a fraudulent warrant.

Deponent further says that during his term as superintendent the sum of \$3,000 was never spent upon repairs; that all of the repairs that were put upon Wetumka School during that time were put upon it by him and paid for by him, and that the Creek government is not indebted to any person in any amount for repairs during that period; that he had no knowledge of an appropriation of \$3,000 being made in the year 1894, and a warrant being issued for same to the board of education June 10, 1895; that he believes the warrant, based on old warrant No. 8312, which was passed upon as valid by examining committee, and reissued to J. A. Harris, of Wagoner, was a fraudulent warrant, and surely that the Creek government does not owe this money.

Deponent further says that old warrant No. 8303 for \$2,500, issued to William Robinson February 18, 1893, has been paid in full by the Creek government, and ought to have been canceled, and the warrant presented to the examining committee, No. 8303, for the above amount, upon which they directed to be issued to James Egan a new warrant for the above amount, must have been a duplicate and hence a fraud upon the government of Creek Nation. The government paid said warrant at or about the time it was issued.

The warrants issued to pay for building this school were all issued in 1894.

W. A. Maddin, being duly sworn, upon his oath says: That since the year 1883 continuously he has been a contractor and builder, located at Muskogee, Ind. T. That as such contractor he built the Eufaula High School and the Creek Orphan asylums,

both the one that was built in 1891 and was destroyed by fire and the one that was

built in 1892 and 1893 and now standing.

Affiant further says that the Eufaula High School building contract was let to him March 10, 1892; that the work of construction was begun in April, 1892, and the building completed in December, 1892. That the contract price of said building was \$11,000, and that the building was completed for the contract price; that the payments for said work were made to him as follows: June 9, 1892, cash, \$4,500; July 14, 1892, cash, \$500; July 22, 1892, cash, \$2,000; August 8, 1892, cash, \$1,000; August 20, 1892, cash, \$3,000; that the contract for the first Creek orphan school or asylum was let to him April 11, 1891, and the building was completed August, 1891; that the contract price of said building was \$13,000; that the payments to him for said building were made as follows: May 1, 1891, check on First National, Muskogee, for \$2,000; May 28, 1891, check on First National, Muskogee, for \$8,000; July 31, 1891, Creek warrants for \$3,000.

That the contract for the second Creek orphan school or asylum, built on the ruins of the old one, was let to him March 21, 1392, and the building completed in January, 1893; that the contract price of said building was \$13,146, paid to him as follows: October 1, 1892, cash, \$3,000; November 8, 1892, cash, \$666.66; November 18, 1892, cash, \$1,500; December 12, 1892, cash, \$1,000; January 4, 1893, cash, \$2,000; February 6, 1893, Creek warrants, \$5,089.08.

The \$3,000 of warrants received on first Creek orphan school went to Turner Hard-

ware Company and the \$5,089.08 given me in warrants as final payment for last Creek orphan school I have presented to Creek treasurer and they have been paid.

The statement hereto attached is a correct copy from my books.

STATE OF TEXAS, County of Grayson, 88:

C. S. Cobb. of Denison, Tex., makes the following statement with regard to Creek warrants:

I am president of the National Bank of Denison, Tex. The said bank does not own any of the Creek warrants except about \$2,500 held as collateral for indebtedness against Grayson Brothers, of Eufaula, Ind. T., \$2,300 of which were turned over about December 10, 1895, by Grayson Brothers' clerk, of Eufaula, Ind. T., to R. L. McDonald & Co., of St. Joe, Mo., without the consent of deponent; also about \$1,100 held as collateral for F. Severs, of Muscogee; also about \$9,000 of warrants held as collateral for debt owing H. B. Spaulding & Co., Checotah, Ind. T.

In 1892 and 1893 said bank had dealings with J. M. Perryman, now deceased but then president of the board of education of the Creek Nation; said Perryman was

then looking after and superintending the erection of buildings in the Creek Nation for school purposes. It is my best recollection that the Eufaula High School was then being built.

Among the transactions the bank had with said Perryman the records of our bank show the following facts: On June 7, 1892, the bank loaned said Perryman \$5,000. This loan was made to said Perryman as the president of the board of education of the Creek Nation. The records of the bank fail to show what collateral was used by Perryman to secure the note, but from my recollection I am sure Creek warrants were employed as collateral.

This note was paid August 6, 1892, at the time the semiannual Creek money was paid the nation for the United States Treasury, and I am certain that said Perryman depended upon such fund to pay said note. I have no record showing the description of the warrants left with me as collateral for the \$5,000 loan; but when on August 6, 1892, the note was paid, the warrants used as collateral were surrendered, and I have no doubt they were paid off in part by the Creek treasurer, and the money used in their payment was employed to pay the \$5,000 note. On looking 'again at my records, and finding a letter of remittance dated August 6, 1892, the date the note was paid, I find that a \$5,000 Creek treasurer's draft on the subtreasurer of St. Louis, was sent by me to the National Bank of Commerce, of St Louis, Mo. I am sure said draft for \$5,000 was given in payment of the note of said Perryman for that sum. Again, on December 31, 1892, the bank loaned said Perryman the sum of \$2,000, which he secured by the deposit of a Creek warrant for \$3,000 (No. A2518). This note was paid February 6, 1893, in full, by a draft made by Sam Grayson (then Creek treasurer) on the subtreasurer of St. Louis, Mo., the bank having previously sent said warrant to said Perryman for collection and remittance. This was also the time of the regular semiannual payment of Creek funds by the United States Treasury.

J. P. Davison, being duly sworn, on his oath says that he has been superintendent of the Pecan school from 1891 until the present time, except from November, 1895, to about February, 1897, continuously. That in 1892 the annual appropriation was for \$5,000 and was paid to him by the quarter, \$1,250 per quarter. Tam very certain that there never has been issued to me a warrant for the sum of \$2,250; and "old" I am very certain warrant "No. 8306, dated June 20, 1892, payable to J. P. Davison, supt. P. C. S., for \$2,250," is a spurious and fraudulent warrant. The Creek Government does not owe any money on account of that year.

The investigating committee, consisting of Messrs. Gibson, Crabtree, and Stidhem, have, I understand, audited this warrant and directed the principal chief to issue, and that he has issued, a new warrant upon this old one destroyed. Government doesn't owe the money and a fraud is being practiced upon it.

Turner & Co., with the exception of one warrant which was transferred to C. W. Turner; and that he is under the impression that all these warrants have been paid.

S. B. Callahan says that in 1894 there was appropriated \$1,000 to be used by Roley McIntosh, Peter Ewing, of Eufaula, and William Anderson, of Sapulpa, to investigate the status of intruders with a view to removing them; this appropriation was

all used up by them.

There was also a subsequent appropriation, I think, of same amount for the same parties, and this was all used by them—at least warrants were issued; there was also made in 1894 or 1895. Then in 1895 (December 18) Isparhecher had appropriated for his use \$3,000 to expel intruders. Roley McIntosh used \$500 of this, S. B. Callahau \$100, and \$600 to the judges and prosecuting attorneys for the six districts. The money on them was eventually paid. There is an unexpended balance of about \$1,000 of that fund.

Taylor Chissoe, being duly sworn, upon his oath says that he was member of school board 1891, 1892, and 1893; that there never was due him and never was issued to him a warrant on the Creek Government for \$1,500; and that "old warrant" No. 8309, presented to Eufaula committee as having been issued to him July 7, 1892, for \$1,500, must have been a forged warrant, such sum never having been due him from Creek Government. He was only entitled to \$600 per annum, and this was paid him quarterly, \$150 per quarter. Creek Government don't owe me anything on account of salary.

Samuel C. Davis, being duly sworn, on his oath says that he is a half-breed Creek Indian; that he is 25 years old, a citizen of Tulsa, Ind. T., and that he was private secretary to Principal Chief L. E. Perryman continuously from the latter part of 1892 until the chief was impeached and deposed in 1895; that one of his duties as said private secretary was to issue the warrants for the chief, and that he issued the most of these warrants. He says that the custom of the office was to follow the law in the matter of issuing all warrants, i.e., the Creek statute provided that all appropriations for the support of the various schools of Creek Nation were to be paid in quarterly payments, and that this was the unvarying custom of the office; that there never was issued a single warrant out of said office by Chief Perryman for the full sum of an appropriation for the support of any school in the nation for an entire year, and that any old warrants upon which new warrants were issued which were for the sum of a full appropriation were forgeries. And he believes that warrants Nos. 8297, dated May 12, 1894, building Eufaula High School, \$13,000; 8310, dated June 10, 1893, to D. M. Hodge, \$500; 8309, July 7, 1892, Taylor Chissoe, board of education, \$1,500; 8305, April 20, 1893, support Coweta school, \$2,750; 8304, dated January 16, 1892, to board of education Eufaula school for \$6,000; 8296, March 3, 1893, J. M. Perryman, building Creek Orphan School, \$12,000; 8306, June 20, 1892, J. P. Davison, superintendent Pecan school, \$2,500; 8301, February 10, 1893, to S. B. Callahan, superintendent Wetumka school, \$2,500; 8301, February 22, 1893, T. W. Manuel, Tallahassee school, \$500; 8302, February 22, 1893, T. W. Manuel, Tallahassee school, \$2,500; 8308, July 15, 1892, William Anderson, intruder commission, \$1,000; 8303, February 18, 1893, William Robinson, superintendent Wetumka school, \$2,500; 8307,

June 1, 1892, J. M. Perryman, superintendent Eufaula High School, \$2,500, were all bogus warrants, not only because warrants were never issued for these amounts, but for the further reason that these warrants are all numbered 8000 or more (except one, the stub of which is gone), and that there were no warrants of as high a number as this issued prior to the year 1895; that he himself purchased the book of blank warrants numbered from 8000 to 9000, and that during L. C. Perryman's tenure he only used a few of these warrants.

He knows of his personal knowledge that no warrants numbered as high as 8000 were issued prior to 1895, and consequently none prior to his incumbency as private secretary, and that he knows the following old warrants, No. 7007, dated March 17, 1895, to T. W. Manuel, support Tallahassee school, \$2,250; No. 7006, May 20, 1895, to William Robinson, support Wetunika school, \$2,250; No. 7006, April 15, 1895, hoard education, building Euchee N. S., \$5,000; No. 7008, July 7, 1894, Supt. N. Y. school, \$5,600, were not issued by Chief Perryman, because the warrants for these purposes

were all issued in small amounts.

Burrell Cox, in talking to Colonel Corkins and myself one day, said that warrants could be "got through" or favorably passed upon by the investigating committee at Eufaula by paying them about 38 per cent of the face value of the warrants. In the summer of 1895 Ed. Egan, a brother of James Egan, who now holds some \$23,000 of the Isparhecher warrants, succeeded in getting possession of Chief Perryman's warrant book and put it in the safe of his brother James, and when Chief Perryman got the book of warrants back some twenty, up to about the number 8200, had been extracted. After this James Egan and Burrell Cox came to Chief Perryman and asked him to give them an order on Ed. Egan for the blank warrants he had taken from the book. This Chief Perryman at first refused to do but, when they, James Egan and Cox, offered him \$5,000 for said order he gave it to them. They afterwards refused to give the chief the promised money.

C. H. Warth, being duly sworn, deposes and says: That in the fall of 1894 he purchased of L. W. Colby, attorney for the Creek Nation, warrant No. A5758, for \$500, and warrant No. A5759, for \$500, both issued on November 24, 1894, to said L. W. Colby as attorney for said nation. These warrants were substantially audited by the national auditor on November 29, 1894, and were by me presented for payment to the national treasurer, and were estimated and considered in the amount presented to the treasurer, Sam Grayson, in February, 1895, and prorated with the balance of the warrants so presented at that date—that is, the pro rata was paid and other warrants of smaller denominations surrendered in their stead.

Afterwards, in the year 1895, a special committee, known as the Le Blanche committee, was appointed by the Creek council to register all outstanding warrants. The committee refused to register the two warrants above named, on account, as stated by them, of some irregularity on the part of the chief, L. C. Perryman, in

issuing the warrants.

Thus, after these warrants had been in the hands of the bank for over a year and had been duly audited and acknowledged by the national treasurer, I was for the first time advised of the claim that they were irregular. They being in due form and issued by the lawfully authorized officers of the Creek Nation, I believed them to be perfectly regular. In view of the difficulty of collecting the warrants, I took advice of one of the directors and concluded to offer to surrender the two \$500 warrants to the nation for a new warrant for \$700, conditioned that said warrant for \$700 should be paid at the approaching payment of warrants. I filed the two \$500 warrants above described with G. W. Stidham, one of the members of the warrant committee, with the proposition, if within their jurisdiction to consider the matter, that we would take a new warrant for \$700 in full settlement of the claim. Stidham stated to me that they had full authority to consider the matter; that he would present it to the committee, and, as far as he was concerned, he saw no objection to it. There was no promise or tender of reward or consideration of any nature made or mentioned between us at that or any other time, nor any intention on my part to influence the action of the committee in passing upon these warrants.

Some time clapsed and I had not been advised of any action having been taken in this matter, and I wrote to the secretary of the chief inquiring about it, but received no reply. Afterwards I met Mr. Lynch, of the chief's office, in Muscogee, and inquired of him concerning it. He said no report had been received from the warrant committee. I met Mr. Crabtree, member of the warrant committee, in Muscogee, on his way to market with a load of cattle, and in answer to my inquiry he said the committee had acted favorably on my warrants, and the report had been

held for signatures of some of the committee. He told me he had or would write to S. B. Callahan, secretary to the chief, stating the agreement with reference to the warrants, and that I would carry it out. Later on Callahan brought and delivered to me a new warrant for \$1,000, and asked as to the manner in which I would cover into the treasury the \$300. I said to him that my proposition was to accept a \$700 warrant and surrender the two \$500 warrants to the nation, on condition that the \$700 should be paid at the approaching payment; but as he had bought the warrant for the full \$1,000, I would accept it and agree to pay into the treasury the \$300 when the warrant was paid, and it was accordingly so arranged. I neither paid nor promised to pay one cent to any one other than the \$300 in the manner and for the purpose above stated.

J. W. Wallace, cashier First National Bank of Wagoner, being sworn, says that he is now and has been cashier First National Bank of Wagoner since it opened. He says that E. B. Childers has not now and never has had deposited with First National Bank of Wagoner any Creek warrants as collateral security; that the First National Bank of Wagoner was approached by Childers and asked to buy a half interest in \$28,000 of Creek warrants at about 80 cents on the dollar; that the bank refused to enter into an arrangement with Childers about it, and never has bought, sold, or held any Creek warrants of Childers.

Deponent further says that Childers has not now on deposit, as treasurer of the Creek Nation, any money whatever, and that he has not had since December 18 any account with this bank as treasurer, and that his total deposit as treasurer amounted to \$2,891.25. Childers has had an individual account here almost since the bank opened. On August 16, 1897, Childers drew out of bank on his check \$5,000 in gold coin, and this left a balance to his credit of \$2,976.57. This sum constitutes part of his present balance, which amounts to-day to \$2,340.74.

At the present time I have of Childers's money, as collateral scenrity, \$7,500, which was paid to me by checks, \$4,500 First National, Muscogee, and \$3,000 on First National of Wagoner. These checks I have subsequently cashed. The check which was given me in lieu of the check on the subtreasury at St. Louis was given in consequence of a telegram from Warth, of First National Bank of Muscogee, dated at Kansas City, authorizing Childers to draw on Muscogee National Bank for \$3,000.

pany, of which firm he is a member; that these warrants he has sold to Mr. E. B. Childers and got the money for them.

Deponent further says that warrant No. 403, general fund, for \$5,000, and warrants Nos. 177, for \$4,500, and 178, for \$4,700, school fund, issued by Isparhecher in his name, do not and never did belong to him; that he never presented to the examining committee warrants for any such amounts, and never authorized the use of his name in the matter of issuing same; that the old warrants upon which the three last-named warrants were issued were presented to the examining committee, Messrs. Gibson, Crabtree, and Stidhem, by E. B. Childers, and the committee directed by Childers to direct the principal chief to issue them in my name. When they were presented to me for indersement I made inquiry as to the meaning of it and was advised that Mr. Childers, being treasurer, it might complicate his accounts to carry these in his own name, and without giving the matter much thought I indorsed the warrants. I have not now and never had any interest in said warrants, and don't know where Childers obtained them, or in whose possession they are at this time.

The undersigned, members of the commission appointed on behalf of the Muscogee Nation to confer with the Dawes Commission to formulate a treaty between the two nations, and at present acting in said capacity, being advised that the investigating committee, composed of Messrs. Gibson, Crabtree, and Stidhem, has reported to Isparhecher that the Creek Nation was indebted to us in the sum of \$295.55 each for services rendered as members of the above-mentioned commission, and that there were presented to the above-named investigating committee, for their action, warrants of the Creek treasurer payable to us in the above-named sums, and the said committee returned said warrants to the principal chief as valid warrants, and that he issued new warrants for said sums, said warrants being numbered as follows:

We are further advised that a list of the "Isparhecher" warrants issued in lieu of the old warrants, which were to be destroyed by the chief when the new ones were issued, was given to Indian Agent Wisdom and by him forwarded to the Commissioner of Indian Affairs, and that by said report the above amounts are reported to be due us.

We desire to say that when the "old" warrants were issued to us we presented them to the various merchants, and we have been paid in full on said account; and, further, that the warrants reported to be outstanding against the Creek Nation, and due us, are not now and never have been in our possession, and that the person or persons who presented them to the investigating committee did so without our knowledge or consent.

The situation seems to be that duplicate warrants have been issued for the same services. We have already been paid, and the payment of the above-numbered warrants would be a fraud upon the Creek Nation. We therefore ask that when they are presented for payment the same be immediately canceled and turned over

to the chief of the nation.

Tulsa, Ind. T., October 11, 1897.

T. E. Smiley, of Tulsa, Ind. T., makes the following statement with respect to the warrants of the Creek Nation issued to him:

I do not now nor have I ever had any interest in any warrants issued on the order of the examining committee at Eufaula on which new warrants were issued.

Warrant No. 368, drawn on the general fund of the Creek Nation for \$150, and warrants Nos. 167 and 168, each for \$7,490, in all \$15,130, appear to have been issued in my name, but I did not own the original warrants upon which these warrants were

based, nor do I have any interest in either one of said warrants.

These warrants all belonged to Burrell Cox, of Tulsa, Ind. T., so said Cox informed me. About June 1, 1897, I loaned Burrell Cox \$800 in money, which, with what he had prior to that time borrowed of me, amounted then to about \$1,900. To secure the payment of this sum to me, said Cox left with me about \$16,000 of old warrants. When these old warrants were turned over to the committee the new warrants were made out in my name. Said Cox went with me to the committee to get the old warrants favorably passed upon. Cox himself presented them to the committee.

When the chief issued the said new warrants I then found for the first time that the new warrants were issued in my name. I told J. H. Lynch, the secretary to the chief, that I would like to have him reissue the warrants to said Cox, since they were not mine. This Lynch refused to do. I never had possession of them. They

were all returned to Cox.

To pay me the \$1,900 which Cox owed me, I went with said Cox to Muscogee, where he sold one of the warrants amounting to \$7,490 and obtained the money through the Commercial Bank of Muscogee. Cox got some money, I don't know how much, and also a St. Louis draft drawn by First National Bank of Muscogee for \$4,356.50; this draft, with \$925 in cash, Cox gave to me; I sent the draft to the National Bank of Commerce at St. Louis and directed that it be placed to the credit of the Tulsa, Ind. T., Bank for me. With the money Cox gave me and the draft for \$4,356.50 I paid myself what Cox owed me, and the balance I held to Cox's credit in the Tulsa Bank, amounting to about \$3,291.55. I still have of his money in the bank about \$250.

EXHIBIT V.

EUFAULA, IND. T., September 29, 1897.

I, Charles Gibson, of Eufaula, Ind. T., make the following statement as one of the committee authorized to be appointed by the act of the national council of the Creek Nation in the session (regular) of October, 1896, for the purpose of "calling in all outstanding warrants and to examine them thoroughly as to their correctness by comparing them with the stubs from which they were issued and with the appropriations made therefor."

In pursuance of this act, myself, J. H. Crabtree, and G. W. Stidhem were appointed by Hon. Isparhecher, principal chief of the Creek Nation, about December, 1896, and soon thereafter entered upon our duties. It required about five months for the

committee to complete its work.

We carefully examined all the warrants presented to us and endeavored to find out the exact indebtedness of the nation. We examined the warrants presented,

and as nearly as could be traced the same to the original stubs, appropriations, records, auditor's records, etc. There was placed before us all the records of the nation, with the exception of those of the year 1894, when certain books thought to be in the possession of L. C. Perryman could not be obtained. We had great difficulty in arriving at the true indebtedness of the nation, finding that many spurious warrants had been floated. When we were satisfied that a warrant presented for investigation and reissue had been fraudulently issued we stamped the warrant "void" on its face by a stamp kept for that purpose; we also wrote on the back of such warrants the reasons which impelled us to such action. The warrants thus voided amounted to about \$27,000.

When we finished our work we made a report to the chief of all warrants we had decided were genuine. We made a copy of our original report and sent the same to Chief Isparhecher, and the original report containing a list of all the warrants we found to be valid we kept in our office at Eufaula; this original list I have, at the request of Messrs. J. W. Zevely and George C. Ross, United States officers, delivered to these gentlemen for examination, to be returned to me when the same has served

its purpose with these officers.

I may add that, as a matter of fact, the examining committee never signed the report sent to the chief, but on learning that we had inadvertently omitted to sign it, we directed Mr. Callahan, secretary of the chief, to append our names to the

report.

I am, however, certain that the copy of our report sent to the chief was an exact copy of the list submitted to Messrs. Zevely and Ross. The list so given to these officers represents the exact amount, when properly footed or added up, that we found of the outstanding indebtedness of the nation.

I will further say that the appropriation for the payment of the examining com-

mittee was exhausted before the work was completed.

This caused the other members of the committee, Messrs. Crabtree and Stidhem, to stop work before it was completed, and I alone finished the work, and with my own hand, unaided by the other two members of the committee, I made out the full list of the indebtedness of the nation and took a copy of the original list of valid warrants to the chief and retained the original list, which I loaned to Messrs. Zevely and Ross. This original list of what was found to be genuine warrants has not been changed or altered in any respect, or as to any warrant, since I made it; it has been under my exclusive keeping and control. It required nineteen days for me to complete the investigation after Messrs. Crabtree and Stidhem quit their investigation, but this time was consumed principally in making out the reported list.

Charles Gibson, being duly sworn, says the committee of which he was a member for the investigation of outstanding Muscogee warrants, in their reports to the principal chief of the old warrants they considered valid, invariably set out in their said report the description of each warrant passed upon as follows: Number of warrant; date of warrant; to whom issued; for what purpose; year appropriated and whether from the general or school fund and the amount of the warrant; that in every case the exact amount of the warrant passed upon was set out. In passing upon warrants and certifying them to the principal chief for the issuance of new warrants, one member of the committee signed the names of all the committee. It was the custom of all of us to consider together the character of warrants presented.

All of the warrants that were presented for reissue in favor of James Egau were presented by G. W. Stidhem, a member of our committee. The warrants that were presented for reissue in favor of H. F. Jones were all presented by G. W. Stidhem. The warrants presented for reissue in favor of F. M. Davis were all presented by G. W. Stidhem. The warrants presented for issue in favor of J. A. Harris were all presented by G. W. Stidhem. The warrants presented for reissue in favor of T. E. Stiller warrants presented for reissue in favor of T. E. Suiley were all presented by G. W. Stidhem. The warrants presented for reissue in favor of U. B. Gray were presented by G. W. Stidhem. E. B. Childers never appeared before the investigating committee either officially or individually; he never presented any warrants for investigation. We tried to have the chief have him come, and tried to have the counsel direct him to come to aid us, but were unsuccessful.

In our consideration of warrants the manner of doing the work was for one member of the committee to take the warrants presented, another the old stub books, and another the appropriation books. My duty was to examine the warrant presented, read its number, date, appropriation, person to whom payable, and the fund out of which it came. Crabtree held the old stub books, and he either reported that the number, date, and amount, etc., corresponded to the stub, or that the stub was gone. Stidhem (G. W.) claimed that he was familiar with appropriations, having been a member of the council, hence he held the appropriation books, and when I would read out a warrant, unless he found the appropriation the warrant was voided. All of the Egan, Smiley, Gray, Davis, Jones, and Harris warrants, above referred to, numbered 7007, 7006, 7005, 7008, 8311, 8314, 7010, 8315, 8250, 8318, 8312, 7004, 8297, 8310, 8309, 8305, 8266, 8304, 8296, 8306, 8293, 8301, 8302, 8308, 8303, 8307, and 8294, were read to him, and in every instance he reported the appropriation act found.

E. B. Childers sent us two or three small warrants, amounting to something over \$100. I did not know he held or owned or in any manner controlled any other warrants; never had any conversation with him about warrants; never have been to

Wagoner since I have been on the committee.

Stidhem and Crabtree were frequently away from Eufaula, but they told me they were out buying cattle. If either Crabtree or Stidhem have had anything to do with Childers or anybody else in the matter of issuing warrants outside the committee room, I had no knowledge of the fact. When old warrant No. 8297, payable to J. M. Perryman, building Eufaula high school, for \$13,000, was presented, I said it seemed late for it to be presented and thought it remarkable, but Stidhem said we could not help this, and so warrant was passed. I never knew until to-day that the council had passed a resolution directing the treasurer of the Creek Nation not to pay warrants numbered 8250 to 8316, inclusive.

Stidhem, a member of the committee appointed to investigate Creek warrants, in which Stidhem said to me that the committee could have made \$3,000 out of some warrants of a man named Egan, if it had not been for his brother, Theodore Stidhem, talking so much around the country to the effect that the commission was making money out of these warrants; and he wanted me to keep his brother quiet, and told me if I could do so he and I would make \$500 apiece out of it.

EXHIBIT Y.

J. H. Lynch, being duly sworn, on his oath says that he is 38 years old and a resident citizen of the Muskogee Nation. I hold the position of assistant secretary to the private secretary, S. B. Callaghan, of Principal Chief Isparhecher of the Muskogee Nation; have held said position since December, 1895. One of my duties was to issue the warrants on the reports of the committee and to sign the names of Isparhecher, chief, and Callaghan, private secretary. I issued everyone of the warrants. I am satisfied the chief knew nothing about this. Makes the following statement about his connection with the issuance of certain warrants: Crabtree and Stidhem, members of committee, presented reports in favor of T. E. Smiley for \$15,130, James Eagan for \$24,300, R. E. Lynch for \$1,300, and C. R. Reedes for \$2,117.65, in the early summer, some time after May 26, 1897. There were present James Eagan and T. E. Smiley, in addition to Stidhem and Crabtree. Eagan and Smiley didn't come to the office on business.

Crabtree and Stidhem offered me a consideration to issue above warrants—about \$1,600. I issued the warrants while they were there and delivered them to Stidhem or Crabtree—Stidhem, I think. The money was paid to me before I issued the warrants, either by Crabtree or Stidhem; I don't remember which delivered the money. I don't know anything about who holds the warrants now or what became of them

after they were issued. My connection with them then ceased. They left the impression on me that these warrants were all right, but that the holders were willing to pay this much to get them in shape.

Some time later, and after July 12, 1897, G. W. Stidhem, of the Eufaula committee, presented the following reports to be issued on:

There were present in the town when these were presented James Egan, Burrill Cox, Ellis Childers, and Crabtree and Stidhem. As well as I can remember, Crabtree, Stidhem, and Childers came to the office and offered me a consideration to issue warrants on these reports—about \$2,000 being offered. I issued the warrants, the money being paid me before I issued the warrants; the money was delivered to me by G. W. Stidhem.

Don't know anything about these warrants or what became of them; turned them over to the three then present. About July 12 James Egan came to me and offered me \$600 to issue warrant in favor of U. B. Gray for \$6,000. The warrant was issued and the money paid to me at the time, before the warrant was issued—\$400 in currency and a due bill for \$200, which I subsequently collected through the Commercial Bank of Muscogee. I don't know where these warrants are or what became of

About August 5 the First National Bank of Muscogee mailed to the executive office a report of the Eufaula committee in favor of the above-named bank for \$1,000. I held the report for further instructions from either Callaghan or the chief, and it happened that Callaghan was at the office soon afterwards and I mentioned the matter to him, and I think he told me to still hold the report until he could see about it. Subsequently he told me that Warth had agreed to pay, I think, \$300 to have those warrants issued, and he instructed me to issue the warrants, which I did. I was led to believe that the bank or Warth gave to Crabtree \$100, Stidhem \$100, and Callaghan \$100. I know nothing more about these warrants.

None of the reports above referred to were accompanied by old warrants. The old warrants have all been destroyed by me, under Mr. Callaghan's instructions. The new warrants issued by me, as above detailed, to the various parties mentioned were issued according to the reports, so far as the names of the persons to whom they were to be issued were concerned, and for the amounts they suggested, and bear the following numbers and are for the following amounts:

Private Secretary Callaghan didn't pay any attention to this business at all.

I concluded from the fact that Crabtree and Stidhem paid me the money themselves that they had already been paid their share.

Never discussed the matter with anybody other than Crabtree and Stidhem, except one conversation with Charley Gibson, the other member of the committee, and he made the impression upon me that he knew what was going on. Stidhem and Crabtree never came to see me or offered me any money in connection with any other warrants. I was never approached by any holders of any other of the old warrants upon which new ones were issued—only the ones above enumerated.

SIR: Under the act of Congress approved June 7, 1897, entitled "An act making appropriations for the current and contingent expenses of the Indian Department,"

etc. (30 Stats., p. 68), it is provided that—
"Upon the properly authenticated demand of the Creek Nation, made after the passage of this act, the Secretary of the Interior shall, though an officer of the Government, disburse three hundred and thirty-three thousand dollars of the money in the Treasury of the United States belonging to the Creek Nation of Indians, only for the payment of the debts of the government of the Creek Nation: Provided, That no debts shall be paid until by investigation the Secretary of the Interior shall

be satisfied that said nation of Indians incurred said debt or issued its warrants representing the same for a full and valuable consideration, and that there was no fraud in connection with the incurring of said debt or the issue of warrants.

In conformity with this act, the honorable Secretary of the Interior caused the indebtedness of the Creek Nation to be investigated, as you are aware, by yourself, and also by Special Inspector J. H. Zevely and Assistant Attorney George C. Ross, and the reports of these officials were submitted to the Department under the dates of September 7, 1897, November 2, 1897, and February 1, 1898, respectively.

From these reports the Department has found that of the list of warrants contained in your report of September 7 last (aggregating \$208,941.08, payable from the Creek general fund, and \$143,302.08, payable from the Creek school fund; total, \$352,243.16) certain warrants particularly described in the reports of Messrs. Zevely and Ross, amounting to \$11,150 of the general fund and \$74,580 of the school fund, are fraudulent, and that \$2,534.90 of the general fund and \$1,784.43 of the school fund, while not positively shown to be fraudulent, are considered doubtful, and that \$3,443.85 of the general fund and \$211.75 of the school fund have been paid. This leaves \$191,812.33 of the general fund and \$66,725.90 of the school fund (total, \$258,536.23) which are found to have been regularly issued on bona fide indebtedness; that they are now held, with few exceptions, by reputable business men, and recommendation is made

in the report of Mr. Ross, dated the 1st instant, that they be paid.

The Department being satisfied from the data contained in the reports of the investigating officers that the warrants last alluded to, and described by number, name of drawee, and amount, in the said report of Assistant Attorney Ross, on pages 11 to 41, both inclusive, amounting in the aggregate to \$191,812.33 of the general fund and \$66,725.90 of the school fund—total, \$258,538.23—represent the indebtedness of said Creek Nation incurred for adequate valuable consideration, and that there was no fraud in connection with the incurring of said indebtedness, or of the issuing of the said warrants, did, under date of the 3d instant, direct this office to take immediate steps to cause them to be paid by you after you shall have furnished an approved bond in the sum of not less than \$100,000 to cover deposits for such payment, either in whole or by installments. You were notified of this action in office telegram of the 7th instant, and in office letter of the 11th instant you were advised that your bond had been fixed at \$260,000.

Your bond in the sum mentioned has received the approval of the Department. Requisitions will be issued in your favor in four installments, to be placed with the assistant United States treasurer at St. Louis. Upon receiving notice of proper

credit, you will immediately proceed to make payment of the valid warrants.

The receipts of the parties entitled to receive payment must appear on the pay rolls as well as on the warrants presented by them for redemption, and the warrants will be taken up and filed with the original roll when you transmit the same to this office.

All payments must be made by check to the order of the persons entitled to receive same, and must be delivered by you into their hands. Powers of attorney must not

be recognized in any case whatsoever.

Before making any payment, you will require indisputable evidence that the parties presenting the warrants are either the original payee or the present legal owners of the warrants. Should warrants be presented by persons other than the payee, you will require them to furnish evidence that they became possessed of them by legal means. In a case where no evidence of a legal transfer exists, you will serve a proper notice on the payee before making any payment to a holder of a warrant. In the report of Special Inspector J. H. Zevely, dated November 2, 1897, with refer-

ence to this matter, he states the following-named persons as "implicated, beyond a reasonable doubt, in conspiring to issue or procure the issuance of fraudulent Creek

With respect to the above-named persons, alleged to have been engaged in the fraudulent issue of warrants, you are directed to exercise particular care in seeing that any of the warrants herein directed to be paid that may be presented for payment by any of the said persons are supported by indisputable evidence of their validity.

You are hereby directed to require all persons presenting warrants for redemption to make affidavit as to the genuineness of the same, as an additional safeguard in protecting the interests of the Creek Nation, the Government, and yourself, and you will cause a sufficient number of blanks, in the following form, to be printed for the purpose, and, when properly executed, to be attached to each warrant:

I, —, residing at —, being of lawful age and duly sworn according to law, depose and say that I am the lawful owner of warrant No. —, dated —, of the Creek Nation, originally issued to —, on account of ——fund; that to the best of my knowledge and belief the said warrant represents bona fide indebtedness incurred by the Creek Nation for adequate valuable consideration, and that there was no fraud in connection with the incurrence of said indebtedness or the issuance of said warrant. And further deponent saith not.

In case of the death of a payee prior to payment the amount due will be deposited to the credit of the United States under the proper fund, and at the same time a proper explanation will be noted after the name on the rolls, to indicate the reason for withholding said payment.

In all other respects it is desired that this payment shall be made with particular care and in strict accordance with the regulations of the Department and the best business methods; and further, it is expressly directed that no warrants be paid except those enumerated on pages 11 to 41, both inclusive, of the report of Mr. Ross.

When in any particular case you may feel in doubt as to the propriety of making payment you are authorized and directed to withhold same and submit the quesrion, with all evidence and papers bearing thereon, to this office for proper action.

Proper vouchers covering the expenses incurred in having the blank affidavits printed should be forwarded to this office for approval.

Upon completion of the payment the rolls, vouchers, and all other evidence connected therewith will be transmitted to this office as a "special account," and will not be confounded with your regular agency accounts.

A full and comprehensive report of the incidents of the payment should be made by you, and you should include therein specific data relative to action taken in any particular case out of the ordinary course, as, for instance-

Death of payee, amount deposited.

Payment withheld, power of attorney not recognized.

Payment withheld, no evidence of valid transfer of warrant.

Payment withheld, evidence of genuineness of warrant not satisfactory.

For your further guidance in carrying out these instructions, I transmit herewith an official copy of the report of Mr. Ross, above referred to.

I transmit herewith a copy of a form of pay roll to be used by you in this payment. If, in your opinion, there are any essential features omitted in this form which will tend to strengthen it, you are at liberty to make such additions as may be necessary. Five pay rolls will be prepared by you, four of which should accompany your account. This requirement is made necessary by reason of the fact that two pay rolls will be transmitted to Congress with a report of the payment; one copy will be transmitted to the Auditor for the Interior Department; the fourth copy will remain in the files of this office.

SIR: I have the honor to state that, pursuant to instructions issued to me from your office in communication "A, Authority 55371-1898," of date February 23, 1898, directing me to pay certain valid Creek warrants which had been found, after due investigation, to represent debts properly incurred by the Creek government, and issued for a valuable consideration and without fraud. (See act of Congress approved June 7, 1897, 30 Stats., p. 68.)

approved June 7, 1897, 30 Stats., p. 68.)

I proceeded, at the office of Union Agency, Muscogee, Creek Nation, Indian Territory, as fast as practicable, to make such payment, after having entered into bond, which was approved, as a special disbursing officer of the United States, and I now submit the following report:

The whole amount of money placed to my credit with the subtreasury at St. Louis, Mo., to meet said payment was as follows:

The discrepancy of 51 cents between the outstanding warrants and the cash returned to the Treasury is fully explained by the balance sheet attached to the rolls.

I would further state that five pay rolls, according to your instructions, were prepared, four of which are herewith submitted as vouchers to my account, and one has been retained for the files of this agency.

Certain warrants, listed as valid, and which I was directed to pay, were not paid, and the reasons for not paying the same are fully set out in the annotations on said rolls, and to which you are respectfully referred for more specific information.

All payments were made by check to the persons entitled to receive the same and delivered by me to the payee. No power of attorney was recognized, and in all cases I endeavored to carry out your instructions, as the rolls and warrants with indersements thereon will show.

Each and every warrant paid by me was duly canceled at the time of payment, and all such warrants so paid are herewith returned as additional vouchers to the rolls themselves.

Mr. J. W. Zevely, special inspector, was present and supervised the payment, and I acknowledge myself indebted to him for much valuable advice in settling legal entanglements and in guiding me along safe lines in the discharge of my duty.

entanglements and in guiding me along safe lines in the discharge of my duty.

I also acknowledge myself indebted to the Commissioner of Indian Affairs for elaborate and timely instructions, which I endeavored to follow at all times, with due regard, however, to a reasonable discretion which I used to protect myself, and which every paymaster must exercise on doubtful points which it is impossible for instructions always to cover or anticipate.

Whatever else may be said of the payment, I can say, without self-laudation, that it was an honest one, and I believe that it was entirely satisfactory to all parties interested, and that it will stand as a precedent for similar payments in the future.

The payment was marked by no sensational incidents, and only a few persons were present on any given day during its progress, and they represented business interests, and might be said to be the best representatives of such interests in the

Indian Territory. They only seemed to want what was due them, and I believe they received that in every instance, and I do not believe that it will be found that there was any serious mistake made along the whole line of payment, and I feel safe in saying that no fraudulent warrants were honored or cashed by me in this

In this connection, also, I will say that including the payment made by Treasurer Moore, of the Creek Nation, which covered warrants not funded by the act of council, this payment made by me has practically reduced the whole indebtedness of the Creek Nation in round numbers to about \$20,000, and hereafter if their revenues are properly collected and disbursed the nation will soon escape the thraldom of debt, and can so remain so long as it maintains its sovereignty as a nation.

I therefore strongly recommend that hereafter and henceforth all payments made by the Creek treasurer be made under the supervision of a United States disbursing officer, or Indian agent having supervision over said tribe, and that such officer or agent be required to countersign all checks issued by said treasurer. This mode of

payment would be an effectual bar against all fraudulent warrants.

After my accounts have been administratively examined, I respectfully ask to be relieved from the penalty of my bond.
