INTEREST DUE OSAGE INDIANS.

MESSAGE

FROM THE

PRESIDENT OF THE UNITED STATES,

TRANSMITTING

A communication from the Secretary of the Interior relative to interest due Osage Indians, under treaty stipulations.

MAY 15, 1882.—Referred to the Committee on Appropriations and ordered to be printed.

To the Senate and House of Representatives:

I transmit herewith a communication dated the 11th instant from the Secretary of the Interior, together with estimate of appropriation and accompanying papers, to provide, in accordance with treaty stipulations and existing laws, for the payment of certain interest due the Osage Indians.

The subject is presented for the consideration of Congress.

SIR: I have the honor to submit herewith copy of a communication from the Commissioner of Indian Affairs of the 8th instant, with accompanying correspondence, in relation to the interest due the Osage Indians on the net avails of their trust and diminished reserve lands, sold under the second and sixteenth articles of their treaty of September 29, 1865, and subsequent acts of Congress noted therein.

An estimate of appropriation in the sum of \$189,981.17, the amount of interest due said Indians, is also herewith inclosed, and, concurring in the recommendation of the Commissioner, I respectfully request that

the matter be presented for the action of Congress.

DEPARTMENT OF THE INTERIOR, OFFICE OF INDIAN AFFAIRS, Washington, May 8, 1882.

SIR: I have the honor to inclose herewith, in duplicate, estimate of appropriation required to pay the Osage Indians interest on the net avails of their trust and diminished reserve lands, sold under the second and sixteenth articles of their treaty of September 29, 1865, and as provided for by act approved July 15, 1870 (Stats. 16, page 362), amounting to \$189,951.17, with the request that one copy of each be forwarded to the Committee on Appropriations of the House and Senate, respectively with the recommendation that the amount due be embraced in the deficiency or sundry civil bills hereafter to be acted upon by Congress. In view of the fact that the Osages have to their credit in the Treasury, at 5 per centum per annum, a very large principal, the interest on which amounts to a sum more than sufficient to meet their wants and necessities, and aggregating at this date, exclusive of the amount of this estimate, the sum of \$275,000, I have annexed a clause to the estimate providing for the deposit in the Treasury, under the act of April 1, 1880, of any unexpended balance of their interest fund not needed for their support.

TREASURY DEPARTMENT, SECOND AUDITOR'S OFFICE, Washington, D. C., March 22, 1882.

SIR: The Commissioner of Indian Affairs has requested this office to adjust the account of the Osage Indians, so as to show what proportion of the sum of \$236,083.88, brought on the books of the Treasury Department by warrant No. 827 of 1881, should be credited to said Indians as principal. On examining the matter it is found that the Osages have received credit for \$1,028,785.15, under the act of June 16, 1880, as payment in full for all of their lands that were sold prior to September 30, 1880. It is also found that a portion of the proceeds of said lands was covered into the Treasury subsequent to September 30, 1880, and consequently was not taken into account when settlements were made under the act of June 16, 1880. It would seem, therefore, that the Osages have received double credit to some extent, and in order that their account may now be properly adjusted, it is necessary to ascertain what amounts have been covered into the Treasury since September 30, 1880, to the credit of the appropriation for "Fulfilling treaty with the Osages, proceeds of trust lands," on account of lands sold prior to that date.

This information cannot be obtained from the Interior Department; I have, therefore, the honor to request that, if possible, it may be furnished from the records of the Warrant Division.
