SIR: I have the honor to transmit herewith a list of judgments given by the Court of Claims against the United States and presented for payment since the 14th day of June, 1886, the date of the last report of such judgments, aggregating \$2,893,587.72, for the payment of which suitable provision should be made by Congress.
