# CONFERENOE ON SUNDRY OIVIL APPROPRIATION BILL. 

AUGUST 27, 1888.-Laid over and ordered to be printed.

Mr. Forney, from the conference committee on the sundry civil appropriation bill, submitted the following

## REPORT:

[To accompany bill H. R. 10540.]
The committee of conference on the disagreeing votes of the two houses on certain amendments of the Senate to the bill (H. R. 10540) making appropriations for sundry civil expenses of the Government for the fiscal year ending June 30, 1889, and for other purposes, having met, after full and free conference have agreed to recommend and do recommend to their respective houses as follows:

WRITIEN STATEMENT OF MANAGERS ON THE PART OF THE HOUSE.
The managers on the part of the House of the conference on the disagreeing votes of the two Houses on the bill (H. R. 10540) making appropriations for the sundry civil expenses of the Government for the fiscal year ending June 30,1889 , and for other purposes, submit the following written statement in explanation of the action agreed upon by the conferrees on each of the several amendments of the Senate, namely:

$\$ 25,000$ for a light-house at the mouth of Great Wicomico River, Chesapeake Bay;
$\$ 50,000$ for establishing and building a light-house at Newport News Middle Ground, Virginia;
$\$ 15,000$ for establishing isolated houses, at a cost not exceeding $\$ 500$ each, at light-stations for the storage of mineral oil;
$\$ 25,000$ for a light-house at or near Cedar River Point, Green Bay, Michigan.
$\$ 30,000$ for a light station at Point Loma, California;
$\$ 25,000$ for a light or lights and fog-signal at or near Ballast Point, San Diego, Bay, California;
$\$ 50,000$ for a coast light-house near the mouth of the Umpqua River, Oregon;
$\$ 16,000$ for pier lights in Lakes Superior, Michigan, and Ontario; and
$\$ 32,500$ for completion of a supply steamer for the Atlantic and Gulf coasts.
Strikes out of the bill the following items proposed by the Senate, namely :
$\$ 40,000$ for a light-house westward of Orooked River, Florida;
$\$ 25,000$ for a light-house at or near Saint Joseph's Point, Florida;
$\$ 50,000$ for pedestal and approaches to Statue of Liberty, New York;
$\$ 40,000$ for establishing a light-ship near Busl's Bluff Shoal, Virginia;
$\$ 15,000$ for a wharf at Astoria, Oregon ; and
$\$ 85,000$ for a steam tender for the eleventh light-house district.

On amendments 65 and 66, appropriates for the Revenue-Cutter Service $\$ 925,000$, and for completing the construction of a revenue steamer for the southern coast, $\$ 36,500$.
On amendments $67,68,69$, and 70 , strikes out of the bill the provisions limiting the number of plate-printers and plate-printers' assistants that may be employed in the Bureau of Engraving and Printing, and appropriates for engravers', printers', and other materials, and for miscellaneous expenses of the Bureau, $\$ 189,000$.

On amendments 71, 72, 73, and 74, relating to Light-House Establishment, appropriates-
$\$ 300,000$ for repairs of light-houses;
$\$ 585,000$ for salaries of keepers of light-houses;
$\$ 3,000$ for inspecting lights ; and
$\$ 250,000$ for lighting of rivers, including lights at Ohicot Pass, and to mark navigable channel along Grand Lake, Louisiana.

On amendments 75, 76, 77, and 78, relating to the Coast and Geodetic Survey, appropriates-
$\$ 2,700$ for additional draughtsmen;
$\$ 1,800$ for additional computers; and
\$1,800 for additional engravers.
On amendment 79, appropriates $\$ 37,500$ for punishment for violations of internal-revenue laws.

On amendment 81, appropriates $\$ 60,000$ for distinctive paper for United States securities.

On amendments 82 and 83 , limits the appropriation for furniture and repairs to furniture for public buildings to objects exclusive of personal services, except for work done by contract.
On amendment 87 , appropriates $\$ 2,000$ for investigating pay and bounty claims of Indian soldiers.
On amendment 88 , appropriates $\$ 30,000$ for compensation in lieu of moieties.

On amendment 89, appropriates $\$ 35,000$ to enable the Secretary of the Treasury to carry into effect the provisions of an act relating to the anchorage of vessels in the port of New York.

On amendment 90 , appropriates $\$ 50,000$ for the expense of enforcing the alien contract labor laws.

On amendment 91, appropriates $\$ 450,000$ additional to permanent appropriation for collecting the revenue from customs.

On amendment 92, provides that the building known as the Armory Building, in Washington, shall be occupied as at present, jointly by the United States Oommissioner of Fish and Fisheries, and by the National Museum.

On amendment 93, appropriates $\$ 2,500$ for rent of office for the United States Fish Commission.

On amendments 94 and 95 , appropriates $\$ 8,000$ for establishing a fishculture station at Neosho, Mo., and $\$ 5,000$ for maintenance of same.

On amendment 108, appropriates $\$ 1,500$ for the erection of reservoirs for drinking water in the Oapitol Building.

On amendment 109 , appropriates $\$ 6,087$ for the purchase of additional ground to be used in connection with the Senate stables.
On amendment 117, applies the appropriation for incidental expenses of the several land offices to clerk hire and rent.
On amendment 120, appropriates $\$ 10,000$ for the preparation of a report on the mineral resources of the United States.

On amendment 124, appropriates $\$ 25,000$ for the construction and completion of an infirmary building for the sick, including all heating
and lighting apparatus for the same, for the Government Hospital for the Insane.

On amendment 125 , appropriates $\$ 2,500$ for the education of feebleminded children belonging to the District of Columbia.

On amendment 126 , appropriates $\$ 1,500$ for tools, materials, and wages of instructors for industrial department of the Howard University.

On amendments 131, 132, 133, and 134, relating to Indian affairs, strikes out proposed appropriation of $\$ 6,803.13$ to re-imburse the Board of Home Missions of the Presbyterian Charch for building and other improvements at Albuquerque, N. Mex. ; appropriates \$25,000 for payment per capita to Western Miami Indians from the fund to their credit in the Treasury of the United States, and $\$ 40,000$ for payment per capita to Kaskaskia, Wea, Peoria, and Piankeshaw Indians, to be charged to said Indians on the books of the Treasury Department and the bonds representing the amount paid to become the property of the United States.

On amendments 135 and 136, appropriates $\$ 9,326.21$ to pay the State of Florida the expenses of taking the census of said State.
()n amendments 137 and 138, appropriates $\$ 250$ for expenses of examinations held elsewhere than at Washington by the Civil-Service Commission.

On amendment 139, appropriates $\$ 15,000$ for expenses of international exchanges under the Smithsonian Institution.

On amendments 140,142 , and 143 , appropriates $\$ 125,000$ for preservation of collections of the National Museum, and places the provisions relating to the Museum under the control of the Secretary of the Smithsonian Institution as director of the National Museum.

On amendments 144 and 145, relating to the Rock Island Arsenal, strikes out the provision for a new hospital building, and appropriates $\$ 25,000$ for repairs of dikes and embankments for the water-power pool.

On amendments 146 and 147, relating to the Kennebec Arsenal, Maine, appropriates $\$ 2,000$ for repairs, etc., aud $\$ 2,000$ for introducing city water, and for necessary changes in plumbing work.

On amendment 149, appropriates $\$ 18,000$ for completing magazine No. 4 and $\$ 1,150$ for repairing magazine No. 1 at Piccatiny Powder Depot, Dover, N. J.

On amendment 150 strikes out the provision of $\$ 7,000$ for erection of one frame building for officers' quarters at the New York Arsenal.

On amendment 151, strikes out provision of $\$ 11,900$ for system of sewerage at the Watertown Arsenal, in Massachusetts.

On amendment 152, appropriates $\$ 10,000$ for an artesian well at the Augusta Arsenal, in Georgia.

On amendments 155 and 156 , appropriates $\$ 10,500$ for care and maintenance of the Washington Monument and the operation of the elevator and machinery connected therewith; discontinues the joint commission for the completion of the monument, and continues the Washington National Monument Society.

On amendments 157,158 , and 159 , relating to the building for the Army Medical Musenm and Library, appropriates $\$ 850$ for cases, shelving, etc., for the laboratories, and $\$ 775$ for additional cases for the museum hall; and strikes out the provision of $\$ 1,850$ for asphalt pavements in the yards.

On amendment 160 appropriates $\$ 2,150$ for completion of repairs and improvements on the old Maseum Building on Tenth street between E and $F$ streets.

On amendments $161,162,163,164,165,166$, and 167 , appropriates $\$ 150,000$ for the construction of buildings at and the enlargement of such military posts as in the judgment of the Secretary of War may be necessary.
$\$ 150,000$ for continuing the work of building for the cavalry and artillery school at Fort Riley, Kans. j
$\$ 50,000$ for the military post at Denver, Oolo. ;
$\$ 30,000$ for the military post at Fort Robinson, Nebr.;
$\$ 30,000$ for the military post at Fort Niobrara, Nebr., and
$\$ 3,000$ for the purchase of additional land adjoining the military res. ervation of Fort Meade, Dak.; and strikes out the provision of $\$ 3,437$ for payment for private property taken by the Government in extension of the military reservation at Fort Thornburgh, Utah.

On amendment 168, appropriates $\$ 25,000$ for roads and bridges in the Yellowstone Park.

On amendment 173 appropriates $\$ 45,000$ for rent and other expenses of offices maintained at stations for the Signal Service outside of Washington.

- On amendment 190 , appropriates $\$ 16,000$ for repairs of roadways to national cemeteries.

Un amendment 195, appropriates $\$ 32,000$ for the completion of the monument at Washington's headquarters at Newburgh, N. Y.
On amendments 197 and 198, appropriates $\$ 10,000$ for maintenance of the Garield Hospital.

On amendment 199, provides that hereafter, before publication of any volume of the Official Records of the War of the Rebellion, the manuscript copy shall be submitted to the Secretary of War and revised by him, and shall not be published until he shall certify that it only contains the contemporaneous official records of the war of the rebellion as provided for by the legislative appropriation act for 1887.

On amendment 200, appropriates $\$ 10,000$ to construct a wagon road from the bonndary of Pike's Peak Military Reservation to the signal station on Pike's Peak.

On amendments 201, 202, and 203, relating to the military prison at Fort Leavenworth, Kans., appropriates $\$ 3,500$ for an electric plant and strikes out the provision of $\$ 2,500$ for the construction of an icehouse for storage of ice.

On amendments 204, 205, 206, and 207, relating to the National Homes for disabled volunteer soldiers, reduces from $\$ 90,000$ to $\$ 50,000$ the provision for maintenance at the Pacific branch; appropriates $\$ 40,000$ for additional buildings at that branch; and appropriates $\$ 101,000$ for additional barracks at the Northwestern, Southern, and Western branches.

On amendment 209, appropriates $\$ 55,000$ towards the construction of an additional wing to the Utah penitentiary.

On amendment 210, appropriates $\$ 10,000$ for the completion and necessary repairs of penitentiary in Wyoming Territory.

Un amendment 211, strikes out provision for the pay of official stenog. raphers employed in the United States courts in Utah.

On amendments 212, 213, 214, and 215, appropriates $\$ 10,000$ for defending suits in claims against the United States, and $\$ 5,000$ for defense in French spoliation claims.

On amendment 217, strikes out provision that the accounting officers of the Treasary shall audit and settle accounts of marshals and their deputies within sixty days next after the same are presented for allowance.

On amendment 218, appropriates $\$ 225,000$ for regular fees of United States district attorneys.

On amendment 219 , appropriates $\$ 5,000$ for payment of district attorneys for special compensation.
On amendment 220 , appropriates $\$ 105,000$ for payment of regular assistants of United States attorneys.
On amendment 224, strikes out provision that the accounting officers of the Treasury shall audit and settle the claims of jailers for the support of the United States prisoners within sixty days after the same are presented for allowance.
On amendment 225, limits the provision for pay of bailiffs and criers to not exceeding three bailiffs and one crier in each court except in the southern district of New York.
On amendment 231, provides that hereafter no payment shall be made from the contingent fund of the Senate unless sanctioned by the Committee to Audit and Control the Contingent Expenses of the Senate, or from the contingent fund of the House, unless sanctioned by the Committee on Accounts of the House, and that payments hereafter made upon vouchers approved by the aforesaid committees shall be deemed valid and taken to be conclusive apon all the Departments and officers of the Government; but that no payment shall be made from said contingent fund as additional salary or compensation to any officer or employe of the Senate or House of Representatives.
On amendment 237 , strikes out provision of $\$ 1,000$ to provide for the safe-keeping of such historical documents and papers as shall be presented to the Library of Congress.

The committee of conference have been unable to agree on the following amendments, namely:
On amendment 105, to pay $\$ 50,000$ to the widow of the late Prof. Spencer F. Baird for services as Commissioner of Fish and Fisheries.
On amendments 106 and 107, appropriating $\$ 100,000$ to survey the boundary line between the United States and Mexico.
On amendment 110, striking out the provision inserted by the House requiring the Committees on Public Buildings and Groands of the Senate and House to invite new designs and specitications for the building for the Library of Congress and substituting therefor an appropriation of $\$ 1,000,000$ to continue the construction of the western front of the building under the present plans, and transferring the work to the Chief of Engineers of the Army.

On amendment 116, removing the Bureau of Education to the Pension Building.

On amendment 118, forbidding the use of money appropriated for expenses of depositing public moneys in investigating any case or prosecuting any person in the mining region of the United States for catting, for mining or domestic purposes, d warfed or scrubby timber, unfit to be sawed or hewed into lumber of commercial value.

On amendments 119 and 121 , appropriating $\$ 250,000$ for investigating the extent to which the arid region of the United States can be redeemed by irrigation.
Ou amendments 127 and 128, increasing the appropriation for education in Alaska from $\$ 25,000$ to $\$ 50,000$, and limiting the same to industrial education.
On amendment 221, increasing the sum for special counsel to be employed by the Attorney-General from $\$ 10,000$ to $\$ 40,000$.

On amendments 222 and 223 , to strike out the provisions inserted by the House, preseribing how certain prosecutions under the internalrevenue laws shall be commenced.

On amendments $233,234,236,238$, 239, and 240, appropriating $\$ 10,000$ for purchase of works of art by the Joint Committee on the Library.
$\$ 18,000$ to complete the Catalogue of the Library of Congress.
$\$ 15,000$ to purchase from B. F. Stevens the transcripts of certain State and historical papers.
$\$ 4,500$ to purchase the library of Prof. Arnold Guyot.
$\$ 3,000$ to pay Alonzo W. Church for preparing index to Congressional documents.
On amendments 242, 243, 244, and 248, striking out the provision in the bill as it passed the House requiring the Public Printer to do printing and binding up to the sums allotted for each of the Departments, and increasing the sum for printing of Congress from $\$ 802,000$ to \$952,000,

On amendment 254, making an indefinite appropriation to purchase the square of ground between E and F and Eighth and Ninth streets, on which to erect a public building for the city post-office and other Government purposes.

On amendment 255, making an indefinite appropriation to purchase additional ground for the use of the Government Printing Office.
On amendment 256, appropriating $\$ 200,000$ for the establishment of a Zoological Park in the District of Columbia.

On amendment 257, appropriating $\$ 15,000$ to purchase that part of Battery Island, at the mouth of the Susquehanna River, now occupied by the Fish Commission as a fish-hatching station, and containing 58,300 square feet.

The bill as it passed the Hoase appropriated $\$ 23,332,406.30$, to which the Senate added $\$ 5,174,593.24$, making the total of the bill as it passed the Senate $\$ 28,506,999.54$. This sum was reduced by the conference committee $\$ 1,346,044.72$, and the sum of $\$ 300,000$ was added for new public buildings authorized by law since the bill passed the Senate, together with $\$ 3,500$ for repairs of roadways to national cemeteries, making the net reduction in conference $\$ 1,042,544.72$, and the total of the bill as it now stands $\$ 27,464,454.82$.

The specific items of appropriation involved in the Senate amendments upon which the conference committee have been unable to agree aggregate $\$ 1,872,000$.
