

LEGISLATIVE, EXECUTIVE, AND JUDICIAL APPROPRIATION BILL.

APRIL 7, 1890.—Committed to the Committee of the Whole House on the state of the Union and ordered to be printed.

Mr. BUTTERWORTH, from the Committee on Appropriations, submitted the following

R E P O R T:

[To accompany H. R. 9066.]

In presenting the bill making appropriations for legislative, executive, and judicial expenses of the Government for the fiscal year ending June 30, 1891, the Committee on Appropriations submit the following in explanation thereof:

The estimates on which the bill is based are to be found on pages 9 to 69 and 77 to 84 of the Book of Estimates for 1891, and aggregate in \$21,627,250.70, of which amount there is recommended in the bill \$20,864,326.75.

The appropriations for the same purposes for the current fiscal year aggregate \$20,853,725.81, being \$10,600.94 less than is recommended in the accompanying bill for the service of the fiscal year 1891.

The amount recommended in the bill is \$762,923.95 less than the aggregate estimates submitted.

The whole number of salaries specifically provided for in the bill is 9,979, being 224 less than the number estimated for and 141 more than the number provided for in the law for the current year.

The bill proposes no new legislation.

Changes in the number or grade of officers or employés of the Government, and their rate of compensation, as compared with the current law, are recommended in the bill as follows:

S E N A T E.

The salaries of the 8 new Senators, \$5,000 each, from the new States of North and South Dakota, Montana, and Washington, are provided for, and the sum for clerks to Senators who are not chairmen of committees is increased so as to include 1 additional clerk. Otherwise the bill provides for the officers, clerks, and other employés in the service of the Senate in the same terms as is contained in the current law, except where it is necessary to provide for the difference between the approaching short session and the long session of Congress, making an apparent net decrease of \$4,558 in the sum for officers and employés of the Senate under the appropriation for the fiscal year 1890.

HOUSE OF REPRESENTATIVES.

The salaries of the 5 Representatives from the new States of North and South Dakota, Montana, and Washington are provided for in lieu of the three Delegates from the Territories of Dakota, Montana, and Washington, making a net increase of 2 members of the House, and provision is made for 1 additional session committee clerk now authorized by resolution of the House. Otherwise the bill provides for the officers, clerks, and other employés in the service of the House in the same terms as is contained in the current law, except where it is necessary to provide for the difference between the approaching short session and the long session of Congress, making an apparent net reduction of \$32,885.06 under the appropriation for the fiscal year 1890.

EXECUTIVE OFFICE.

The salary of the assistant secretary is increased from \$2,250 to \$2,500. A door-keeper to the President at \$1,600 is provided for in lieu of an usher to the President at \$1,400. A chief door-keeper at \$1,800 is provided for and the number of door-keepers at \$1,200 each is reduced from 5 to 4.

CIVIL SERVICE COMMISSION.

An increase is made of 1 clerk of class 4, 1 clerk of class 2, 2 clerks of class 1, and 1 clerk at \$1,000.

TREASURY DEPARTMENT.

SECRETARY'S OFFICE.

The following reductions are made: In the division of appointments, 1 laborer, \$660; in the division of loans and currency, the superintendent of paper-room is reduced from \$1,600 to \$1,200; and 1 clerk of class 1 is provided for in lieu of 1 clerk of class 2 in the miscellaneous division.

SUPERVISING ARCHITECT'S OFFICE.

A reduction is made of 1 clerk and stenographer at \$2,000, and 1 clerk at \$900.

SECOND AUDITOR'S OFFICE.

An increase is made of 2 clerks of class 4, 2 clerks at \$1,000 each, and 1 skilled laborer at \$900.

THIRD AUDITOR'S OFFICE.

A reduction is made of 1 chief of division at \$2,000, and an increase of 2 laborers at \$660 each is provided for.

SIXTH AUDITOR'S OFFICE.

An increase is made of 5 clerks of class 1, 10 clerks at \$1,000 each, 15 clerks at \$900 each, 15 assorters of money-orders at \$840 each, 15 assorters of money-orders at \$720 each, and 5 assistant messengers.

TREASURER'S OFFICE.

A reduction is made of 5 clerks of class 1 in the force employed in redeeming the national currency.

COMPTROLLER OF THE CURRENCY'S OFFICE.

A chief clerk at \$2,500 is provided for and a reduction is made of 1 chief of division at \$2,200.

DIRECTOR OF THE MINT'S OFFICE.

An increase is made in the salary of 1 helper from \$500 to \$720.

OFFICE OF SUPERVISING SURGEON - GENERAL MARINE HOSPITAL SERVICE.

In the force authorized to be employed and paid from the permanent appropriation for the Marine Hospital Service a reduction is made of 1 surgeon at \$3,000 and 1 passed-assistant surgeon at \$1,800. An increase is made of 1 clerk at \$1,200, and authority is given for the detail of 2 surgeons and 1 passed-assistant surgeon for duty in the bureau.

INDEPENDENT TREASURY.

OFFICE OF ASSISTANT TREASURER AT NEW YORK.

An increase is made of 1 clerk at \$1,400, 1 clerk at \$1,200, and 1 stenographer and type-writer at \$1,400, making an aggregate in salaries of \$4,000, which is given in lieu of a gross appropriation of \$3,500 for clerical force carried in the sundry civil appropriation act for the current fiscal year.

GOVERNMENT IN THE TERRITORIES.

The salaries of the governors, judges, and secretaries for the Territories of Dakota, Montana, and Washington, which were provided for in the law for the current fiscal year, are omitted from the bill, the Territories having become States. These salaries aggregate 22 in number and \$61,200 in amount.

WAR DEPARTMENT.

SECRETARY'S OFFICE.

An increase is made of 1 Assistant Secretary of War at \$4,500.

RECORD AND PENSION DIVISION.

An increase is made of 1 chief of division, \$2,000; 2 firemen at \$720 each, and 1 skilled mechanic at \$1,000.

ADJUTANT-GENERAL'S OFFICE.

A reduction is made of 4 assistant messengers at \$720 each.

INSPECTOR-GENERAL'S OFFICE.

An increase is made of 1 clerk of class 3 and 1 clerk of class 2.

JUDGE-ADVOCATE-GENERAL'S DEPARTMENT.

An increase is made of 1 clerk of class 2.

PAYMASTER-GENERAL'S OFFICE.

A reduction is made of 1 laborer at \$660.

NAVY DEPARTMENT.

The clerical force in this Department is provided for in accordance with the number and salaries specified in the current law, but is rearranged by assignment to bureaus and offices as desired by the Secretary, increases being made only as follows:

SECRETARY'S OFFICE.

1 clerk to Secretary, \$2,250; messenger boy increased from \$240 to \$360.

OFFICE OF NAVAL RECORDS OF THE REBELLION.

1 clerk of class 3, 2 clerks of class 2, and 2 copyists at \$900 each.

INTERIOR DEPARTMENT.

SECRETARY'S OFFICE.

An increase is made of 6 members of the board of pension appeals at \$2,000 each, 1 special land inspector at \$2,500, and 1 fireman at \$720.

GENERAL LAND OFFICE.

An increase is made of 3 principal clerks and 8 chiefs of division at \$2,000 each, in lieu of 3 principal clerks and 8 clerks of class 4 at \$1,800 each, and in addition 2 clerks of class 3, 2 clerks of class 2, 3 clerks of class 1, 1 clerk at \$1,000, 5 copyists at \$900 each, and 2 messengers at \$840 each, are provided for.

PENSION OFFICE.

An increase is made of 1 painter and 1 cabinet-maker at \$900 each, and 15 charwomen at \$240 each.

PATENT OFFICE.

An increase is made in the salaries of the 30 principal examiners from \$2,400 to \$2,500, and in addition 1 clerk of class 4, 3 messengers at \$840 each, and 5 laborers at \$180 each are provided for.

POST-OFFICE DEPARTMENT.

POSTMASTER-GENERAL'S OFFICE.

An increase is made of 1 stenographer at \$1,600, 1 clerk of class 4, and 1 page at \$360, in lieu of 3 clerks of class 1, 1 clerk at \$1,000, 1 copyist at \$900, and 1 female messenger at \$840, dropped.

ASSISTANT ATTORNEY-GENERAL'S OFFICE, POST-OFFICE DEPARTMENT.

An increase is made of 1 clerk of class 1.

FIRST ASSISTANT POSTMASTER-GENERAL'S OFFICE.

An increase is made of 2 clerks of class 4, 1 laborer at \$660, and 2 pages at \$360 each.

SECOND ASSISTANT POSTMASTER-GENERAL'S OFFICE.

An increase is made of 2 clerks at \$1,000 each, 2 clerks at \$900 each, and the salary of 1 stenographer is increased from \$1,400 to \$1,600.

THIRD ASSISTANT POSTMASTER GENERAL'S OFFICE.

An increase is made of 1 assistant messenger, \$720.

DEPARTMENT OF JUSTICE.

An increase is made of 1 Assistant Attorney-General, at \$5,000, and 1 Assistant Attorney-General for the Department of Agriculture, at \$4,000; 3 stenographic clerks, at \$1,600 each; 1 assistant messenger, \$720, and 1 laborer, \$660.

DEPARTMENT OF LABOR.

An increase is made of 3 statistical experts, at \$2,000 each, and a reduction is provided for of 2 clerks of class 4, and 2 copyists at \$720 each.

JUDICIAL.

Incident to the admission of the four new States and the establishment of a court in the Indian Territory, the following additional judicial offices, authorized by law, are provided for: Five district judges, at \$3,500 each; 2 United States attorneys, at \$200 each, and 2 United States marshals, at \$200 each.

The following statement shows in detail by Departments and bureaus or offices and by number of specific salaries the appropriations for 1890, the estimates submitted for 1891, and the amounts recommended in the accompanying bill:
