TRANSMITTING,

In response to Senate resolution of March 14, 1888, information relative to the reservation of the Otoe and Missouri Indians.

SIR: I have the honor to acknowledge the receipt of Senate resolution of the 14th instant, as follows:

Resolved, That the Secretary of the Interior be directed to furnish, for the information of the Senate, a statement of the number of acres embraced in the appraisal and sale of the "remainder of the reservation of the confederated Otoe and Missouri tribes of Indians in the States of Nebraska and Kansas," under the provisions of the act of Congress relating thereto approved March 3, 1881, and published in volume 21 United States Statutes at Large, page 350, said statement to show, as nearly as may be, the appraised valuation of each subdivision of said reservation, and the price at which it was sold, together with the name of the purchaser thereof in each case. He is also requested and also to report whether or not proclamation was made of said sale, or any advertisement of the same, and, if so, what, and furnish copies thereof.

In response to the resolution I inclose herewith a copy of the report of the 23d instant from the Acting Commissioner of the General Land Office, together with its inclosures, giving the desired information.

SIR: I have the honor to acknowledge the receipt, by reference from Hon. D. L. Hawkins, Assistant Secretary of the Interior, under date of March 15, 1888, of Senate resolution of March 14, 1888, calling for a statement showing the number of acres embraced in the appraisal and sale of the remainder of the reservation of the confederated Otoe and Missouri tribes of Indians in the States of Nebraska and Kansas, under the provisions of the act of March 3, 1881, the appraised valuation of each subdivision, as nearly as may be, and the price at which it

was sold, together with the name of the purchaser thereof in each case. Also to report whether or not proclamation was made of said sale, or any advertisement of the same, and if so, what, and furnish copies thereof.

In accordance with directions given by the Assistant Secretary, the following report is submitted in relation to the matter, to wit: The official schedule of appraisement on file in this office, made by the commission appointed to appraise the lands in the above-mentioned reservation, under the acts of March 3, 1881, and August 7, 1882, shows the number of acres appraised as follows:

The accompanying statement (marked Exhibit A) will show the appraised value of each subdivision, together with the price at which it was sold per acre, and also the names of the purchasers of the portion of the reservation lying in the State of Nebraska. The tracts appraised, but unsold, also appear. Exhibit B gives similar data as regards that portion of the reservation in the State of Kansas.

No proclamation was made of the sale of the above-mentioned lands, but notice thereof was authorized to be published in the daily editions of the following named newspapers, prior to the day of sale, in accordance with instructions of the honorable Secretary of the Interior, dated April 24, 1883, to wit: The State Journal, published at Lincoln, Nebr.; The Champion, published at Atchison, Kans.; The Capital, published at Topeka, Kans.; The Republican, published at Omaha, Nebr., and in a weekly paper published at Beatrice, Nebr., known as The Beatrice Express. For form of notice above referred to see Exhibit C.

In addition to the papers enumerated the notice seems to have been published in the Nebraska Staats-Zeitung and the Gage County Independent.

As several bidders who purchased tracts May 31, 1883, made default, all the land in said reservation where the parties failed to comply with the law and the terms of the sale was re-offered and sold December 10, 1883, by direction of the honorable Secretary of the Interior, dated October 12 and 22, 1883.

A form of notice, specifying time and manner of sale, was authorized to be published for thirty days prior to sale in The Champion, published at Atchison, Kans., and State Journal, at Lincoln, Nebr. (daily papers), and in five consecutive issues of The Express, a weekly paper published at Beatrice, Nebr. Notice was also published in the Nebraska Staats-Zeitung. For copy of forms see Exhibit D.

The accounts of the several papers for publishing such notices, with printed number in support of the same, were sent to the honorable Commissioner of Indian Affairs for adjustment. The inclosure received is herewith returned.
