All committees have stayed on task and the general membership will benefit from their efforts as we gather at the annual meeting to select new officers, recognize past and future grant recipients, and enjoy the theme of the awards luncheon "Riding High with Ambassadors." #### **FREQUENTLY ASKED QUESTIONS**

Q: Who serves on the Ambassadors Board of Directors?

A: In accordance with the Ambassadors bylaws the board of directors consists of the elected officers and ten directors. The elected officers are president, president-elect, vice-president, secretary, treasurer, and three members of the nominating committee. The Assistant Director OCES-FCS, and immediate past-president will be ex-officio, non-voting members of the board.

Q: What is the difference between OCES-FCS Ambassadors & the Fitch Fellowship?

A: The OCES-FCS Ambassadors represents those individuals, groups and other interested parties who have an interest in supporting the family and youth programming across the FCS spectrum. Contributions to Ambassadors are unrestricted in terms of how the funding is used except that they be used for educational purposes. The specific direction on the use of these funds is provided by the Ambassadors Board of Directors who established various award categories over the past years. FCS Educators can access a list of the award categories at: fcs.okstate.edu. Go to "educator resources" for details. The total award amounts are limited to the interest generated by the Ambassadors fund.

The Margaret Fitch Fellowship was also made possible by the generous contributions of the friends of Margaret Fitch. The contributions were given in recognition of her contributions to Extension and the field of family and consumer sciences. In the case of the Fellowship, the purpose of the funds was specifically designated to provide opportunity to visit and study a relevant program in another state or country.

The experience should provide the recipient the opportunity to:

- increase understanding of other cultures or ethnic groups;
- learn about teaching strategies and delivery methods that effectively reach other cultures; and
- adapt or adopt educational programs to meet the needs of an increasingly diverse audience.

This focus was a continuation of Margaret's passion for multi-cultural awareness and work. Like the Ambassadors funds, the Fellowship award amount is limited to the interest generated by the principal. Contributions are welcome and can be made to either fund.
