


- AMENDMENT ARTICLE 8 CONSTI-TUTION:

The society shall have authority to elect a Board of Trustees of not more than thirteen members and to provide for articles of incorporation. The president and president-elect shall always be two of the Trustees. The Trustees shall be elected at the Annual meeting in December for a term of one year. Trustees may be re-elected to office.

EIGHT HOUR DUTY FOR NURSES

In behalf of the nurses of Tulsa I wish to take this opportunity to express thanks and appreciation to the doctors for their splendid cooperation in helping to promote the shorter working day for nurses. Since it was started three years ago this system has afforded the nurses time in which to study and engage in various diversions heretofore impossible. Tulsa nurses now have hobbies, as, skating, golfing, reading and walking out in the open and best of all many are going to school again. The eight hour day stimulates a desire for knowledge, study and travel. All of these activities go toward making a more nteresting and versatile nurse for the patients. The opportunity for outdoor exercise and time for proper rest lessens the possibility of contracting the diseases to which they may be exposed.

The expense to the patient is lessened for continuous nursing service, and the new method makes it possible for him to dispense with all nursing service except that which is absolutely essential and have a nurse for one hour only if he so desires. Some of you have questioned the financal side from the nurses' standpoint. The third year of eight hour duty has brought into the nurses' pockets three and one-half times as much money as did the last year of twenty hour duty, this is according to the actual records kept.

With more than one nurse on a case there is competition which means more efficient work. The older nurse must compete with the younger's fresh knowledge of medicines, treatments and their reactions. The younger nurse is competing with the years of experience and practice of the older graduate. Personality and neatness are qualities which must be developed when lacking, now that the patient may have two other nurses with which to compare her. And you must agree that the old way of going about during the day in a fully professional garb and then at night performing one's duties, more asleep than awake. in a state of undress was utterly ridiculous. whether the patient be a man. wo There can be no doubt man or child. that the patients are better cared for by nurses whose energies are alertly concentrated on the patients' needs rather than on a dogged determination to overcome fatigue sufficiently to carry out orders. At the end of a case in the old days the nurse only wished to go home, thinking and caring for nothing but sleep, sleep. You who are not yet all the way for eight hour duty picture yourself in constant attendance with any

one of your many trying patients for twenty hours a day when it is a trial for you to spend the few minutes with them that your daily call requires.

It cannot happen overnight, but the "revolution" in the nursing world is making nursing attractive to the college graduate and the material for student nurses is decidedly improved. Therefore, your nurse of tomorrow won't be the drab, broken-down, uninteresting nurse that too many are today who began doing tweny hour duty twenty-five years ago. She will be a well-dressed, well-bred, well-informed woman taking her place in the business world for the sheer enjoyment she gets out of her career.

May I also add in behalf of the Official Registry that when you have a charity patient who is in real need of special nursing that you call the Registry, 4-3737 and tell Mrs. Beil your troubles and let us help you by giving our services free also.

Thank you, Dr. Hudson, for letting us use this space and when you again need something to fill in space we'd like to get some more off our chest.

REORGANIZATION

At the November 22 meeting given over to the question of reorganization the Board of Trustees recommended the employment of a full time lay executive secretary without delay and submitted a schedule of membership dues for 1938 to cover the increased expense.

The society adopted the recommendation and the schedule of dues by a vote of 73 for the motion, to one against it with two members not voting. 76 members were present at the meeting.

The schedule of dues for 1938 is as follows:

1st	year-	\$16.00
		24.00
	vear-	36.00

The above schedule applies only to the physicians practicing in the city of Tulsa. By first year is meant a physician who is in the first year of practice in Tulsa. By second year is meant a physician who has practiced more than one year but less than two in Tulsa on January 1st or at the time of submitting his application for membership. By third year is meant a physician who has practiced in Tulsa three or more years consecutively whether he is applying for membership or renewing his previous membership.

All members practicing in other cities or towns shall pay \$16.00 regardless of the number of years of practice.

The following item is taken from the Nov. 3, 1937 report of the Tulsa Better Business Bureau:

SENDING CLAIMS OUT OF THE STATE FOR COLLECTION IS ILLE-GAL.

"Evidently there are some business firms, also physicians who are not familiar with Oklahoma Statutes 1931, Section 10023-4-5, which makes it a misdemeanor to send any claim to an out-ofstate agency for collection by proceedings in attachment, garnishment, or other process if the debtor and creditor are within the jurisdiction of the courts of the State of Oklahoma.

This statute provides that anyone violating these provisions is liable to the debtor for a sum equal to the amount claimed plus the debtor's actual expense in the action including attorney fees."


