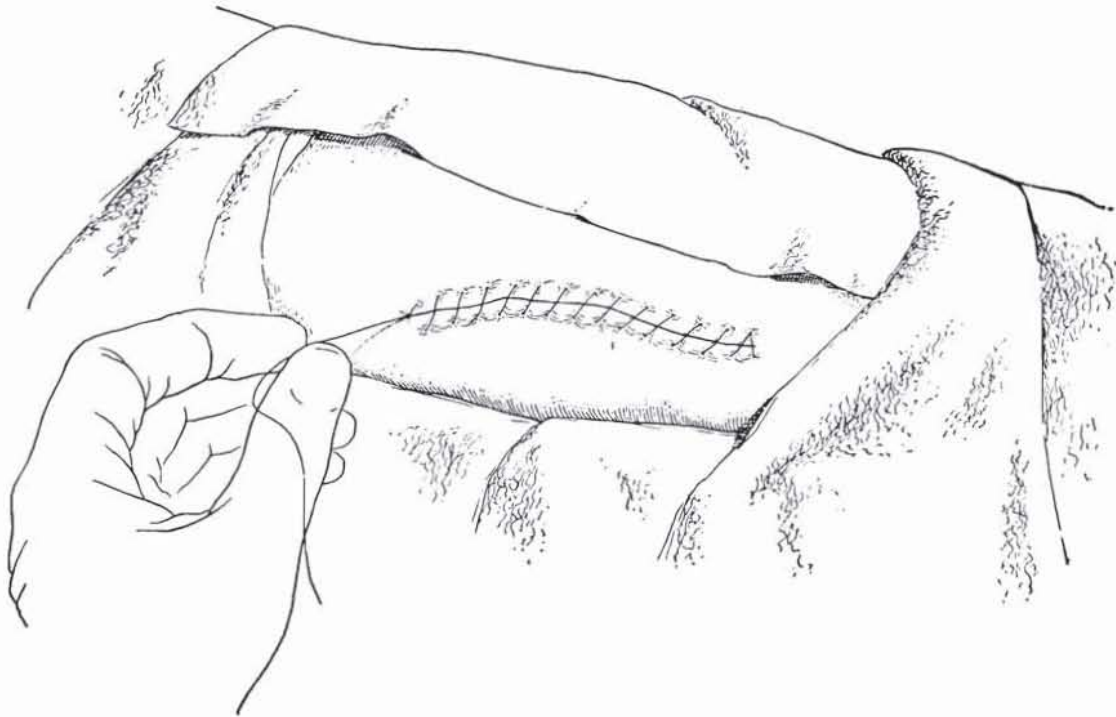

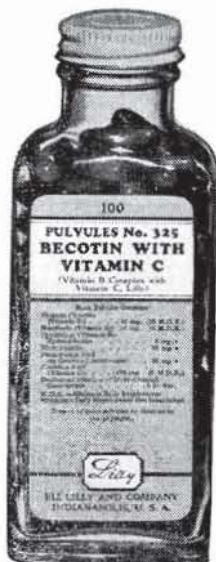

ELECTION OF OFFICERS SCHEDULED

Annual Business Meeting of Tulsa County Medical Society Slated For Monday, December 8. Committee Reports To Be Made At That Time.

Members of the Tulsa County Medical Society will meet Monday, December 8, 1947, in an annual business meeting and election of officers. Seventeen officials will be selected from a list of 79 eligible members. Annual committee reports will be made, and the membership will also approve an operating budget for 1948 and fix the amount of local dues. The meeting will be in the Ivory Room of The Mayo, and will begin promptly at 8:00 p.m.

All committees which have been active will be expected to present an oral report of committee activity for the year. The Executive Offices will provide each committee chairman with a report of committee activity and accomplishments for 1947, and such reports may be used as a basis for the preparation of the official report. The report of the Executive Secretary for the year will be mimeographed and mailed to members during the first week in December.

Officers to be elected are President-Elect (to serve in 1949), Vice-President, Secretary-Treasurer, one member of the Board of Trustees, one member of the Board of Censors, two members of the House of Delegates, and nine alternate delegates. Dr. Victor K. Allen, Tulsa proctologist elected last year, will assume office as President on January 1, 1948. He succeeds Dr. E. O. Johnson, obstetrician.

Due to the length of the program the scientific portions of the program will be omitted. As a requirement of the Constitution & By-Laws, the Chair will request if any discussion of medical fees is desired by the membership.

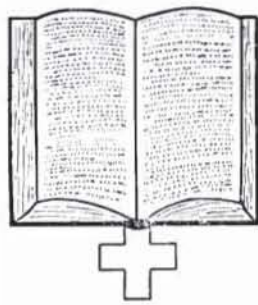
The membership will be presented with a suggested operating budget for 1948, prepared by the Finance Committee and approved by the Board of Trustees. The approval of this budget makes it mandatory to vote or assess an adequate amount of annual dues to support such a budget. The present Tulsa County Medical Society dues are \$50.00 annually. The dues of the Oklahoma State Medical Association, fixed by the House of Delegates last May, have been increased for 1948 from \$22.00 to \$42.00.

Dr. H. B. Stewart is the retiring member of the Board of Trustees. Other hold-over members are Dr. W. A. Showman (1948), Dr. Ralph A. McGill (1949), Dr. H. A. Ruprecht (1950), and Dr. Marshall O. Hart (1951). Trustees serve a term of five years each.

Dr. Victor K. Allen is the retiring member of the Board of Censors. Hold-over members are Dr. Marvin D. Henley (1948) and Dr. Thomas J. Hardman (1949). Censors serve a term of three years each.

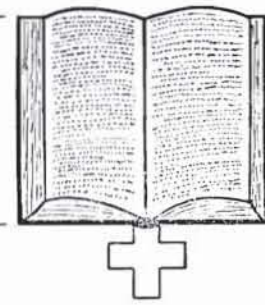
The Tulsa County Medical Society will be entitled to nine seats in the House of Delegates. If the present membership of 222 exceeds 225, the Society will be entitled to a tenth seat. Two regular delegates will be elected, with one delegate to be elected with the provision that he shall not be seated until the membership rises above 225 members. The retiring members of the House of Delegates are Dr. John C. Perry and Dr. L. C. Northrup. Holdover members are Dr. H. B. Stewart (1948), Dr. Walter S. Larrabee (1948), Dr. M. V. Stanley (1949), Dr. H. A.

BETTER PUBLIC RELATIONS SOUGHT

Speakers At AMA Meeting Advocate Widespread Use of Public Relations Programs By Medical Profession. Blue Cross Problems Discussed.

The need for broad plans of public relations by the Medical Profession, embracing all media for the dissemination of educational material to the public, was emphatically stressed by a series of speakers appearing before doctors of Oklahoma and other Southern states at the Regional Conference of the American Medical Association at New Orleans, Louisiana, last October 23-24.

Pointing out that the profession must overcome some growing problems within itself, the nationally-known speakers urged all state and county medical societies to prepare specific programs of public relations, all designed to create a mutual state of good will between doctor and patient. The elaborate public relations plans of several large state societies—notably Michigan, Colorado, Virginia, and the District of Columbia—were singled out for special attention.

Mr. R. H. Graham, Executive Secretary of the Oklahoma State Medical Association, made a firm impression upon delegates as he explained the Association's program of newspaper advertising conducted last year. He was bombarded with questions about the program from doctors from all parts of the South, and the general opinion expressed by observers was for continued programs of this character. Many of the speakers from the floor stated that their professional organizations wished to do public relations work, but lacked adequate counsel by qualified experts. Pointing out that many state and local societies were employing special public relations counsel to prosecute such programs, Dr. George F. Lull, Executive Secretary of the American Medical Association, urged that only qualified persons be retained for such positions. Dr. Lull said desirable experts in this field were now commanding annual salaries in excess of \$10,000.00.

The advocates of such extensive programs were not without their critics, however. Speaking from the floor, several physicians noted that a sound basis for

such programs must first be created in the doctor's own office. Here, it was stated, the physician can do more in the way of effective public relations than all of the formal programs combined. It was further alleged that the formal programs were valueless without the basic cooperation of the doctor in his everyday practice. "We must practice what we preach," one doctor said, "if the public is to believe in our public relations program."

Along this line of thinking, another physician proposed that greater attention be accorded the individual patient—providing ample time for the appointment, giving attention to complaints against service and fees charged, discouraging routine and often necessary use of the laboratory and consultation with specialists, etc. While this point was disputed by many, it nevertheless drew sincere applause from many delegates.

Each doctor in attendance was distributed literature concerning the various public relations plans now in operation in several states. This material is now being studied by officers of the Tulsa County Medical Society with the possibility that similar plan may be incorporated as part of the Society's 1948 program of work.

Another popular subject under discussion at the Regional Meeting concerned the activities of prepaid plans of hospital, medical, and surgical and obstetrical care insurance. Dr. James Stevenson, Tulsa physician and treasurer of Oklahoma Physicians Service, was one of several discussants. Dr. Stevenson devoted special attention to the constant need for cooperation of all doctors with prepaid plans. He pointed out that they could be of assistance in preventing abuses of the plan privileges, both by doctors and by the beneficiary, and also of the important role of the doctor as advisor on medical problems to the various plans.

An interesting discussion of the need for adequate medical care in rural areas failed to evolve any practical solution to

the problem. The present limited capacities of medical schools must be extended, it was agreed, but with the provision that the quality of faculty and physical facilities be not impaired. The often-repeated suggestion that specialty boards require a minimum of three to five years general practice received an excellent reception. However, it was pointed out by some speakers that it did not necessarily follow that such general practitioners would elect to follow a practice in a rural area.

The failure to distribute medical care to the rural areas was noted as a predisposing factor to the successful establishment of a system of state medicine. When private medicine fails to provide such care, one speaker argued, the state or governmental medical care agency will be readily accepted by the public in areas of need. Some of the proffered solutions to this problem were: construction of modern hospital and laboratory facilities in needy areas, preferably by the community itself; extension of prepaid plans of medical care to rural areas; limitation of specialties or an increase in specialty requirements; and, where necessary, to subsidize financially any physician who would agree to come to the community. This latter plan has already been placed

into operation in many communities over the nation, and many general practitioners have been given guarantees of income, gifts of residential property, and loans without interest necessary to purchase needed equipment. As a general rule such inducements fail to attract young physicians to rural areas, however.

The Tulsa County Medical Society's own series of medical broadcasts, "How's Your Health?" is now being heard each Tuesday night at 7:00 p.m. over Radio Station KOME. Dr. Maurice J. Searle, Chairman of the Public Relations-Publicity Committee, said the change to the night time schedule would materially increase the size of the listening audience.

To facilitate the appearance of doctors on the program, the broadcasts are recorded at 1:30 p.m. each Tuesday afternoon, and rebroadcast via transcription at 7:00 p.m. The program features a discussion by a member of the Society of a popular medical subject. Scripts are prepared by the Executive Offices. To date more than 70 members of the Society have appeared on the series in more than 11 years of broadcasting, with 22 appearing during the last year.

PROGRESS AHEAD

The announcement that the Tulsa City Commission has agreed to appropriate a maximum of \$10,000 annually for the employment of a qualified City Superintendent of Health is important news to Tulsa Medicine. With this sum now available it becomes possible to secure the services of a physician who has the education, experience, and ability required by the position. This forward step should have a number of beneficial results to the community and to the City Health Department:

It will at once materially raise the standards of public health maintenance in Tulsa through application of modern public health procedures and techniques.

It will create a much-needed precedent in the city government to permit the employment of qualified professional persons on the basis of actual need and desirable professional requirements, unlimited by niggardly salary schedules which have remained unchanged through nearly a decade of inflationary economy.

It will provide the City Health Department with a firm leadership which should serve to eliminate the cause of many widespread rumors and reports of inefficient operational methods in the Department.

Most of all, it should serve to give the Department the status which it deserves

in the city government, and in the consideration of the city fathers. For many years it has been a step-child of the various city administrations, handicapped by the most limited budgets, suffering at times from political interference, and operating effectively only through the loyalty of a small group of employees.

The success of the efforts to obtain qualified leadership in the Department are due entirely to the tireless activity of an energetic City Health Board, composed of five prominent physicians. The enthusiastic interest which they have shown in the performance of their duties, and the sincerity of their convictions, is deserving of the thanks of the entire community. Working without remuneration, they have contributed liberally of their time and effort in the solution of this problem, and it is certain that they will continue their interest in the creation of a first-rate public health agency for Tulsa. To the City Health Board, the Tulsa County Medical Society extends thanks for a job well done.

A SIGNIFICANT RECORD

From the offices of Group Hospital Service, administrators of the Oklahoma Blue Cross Plan, comes word of the enrollment last month of the 200,000th member of the profession-sponsored plan of prepaid hospital insurance. The attainment of this milestone is particularly gratifying to the Tulsa County Medical Society, whose members provided the original impetus some seven years ago for the creation of the Blue Cross Plan in this State. The efficient operation and constant progress of Group Hospital Service serves to justify the confidence and foresight which many Tulsa physicians exhibited in initiating the Plan, and as a Godfather to Blue Cross the Tulsa County Medical Society is justly proud of a handsome godchild. Later, in 1944, the Society was again partially responsible for the creation of Oklahoma Physicians Service, a companion plan of prepaid surgical and obstetrical care insurance, which has grown into a lusty child of more than 50,000 members.

Group Hospital Service of Oklahoma has attained national recognition as one

of the most efficiently operated plans in the nation. Its benefits, based upon adequate and sensible financial policies, are comparable to those of any other sound plan. Its personnel, to whom much credit is due for the success of the plan, is of top-drawer quality. Its managerial policies are sound and noted for the basic common sense of business administration which they exhibit. Oklahoma Medicine has much to be proud of in this accomplishment, and it has materially benefitted from the operation of the plan. Those physicians and lay persons who have contributed so much of their time to this community project are especially deserving of commendation for their participation.

As Blue Cross approaches its eighth birthday it records a splendid accomplishment of service to the people of Oklahoma and to the medical profession of this State. The even greater potential benefits of Oklahoma Physicians Service are expected to substantially improve the health and welfare of every enrollee. Both plans are striking examples of what can be accomplished by men working to-

gether in the attainment of mutual aims and goals.

PSYCHIATRIST TO SPEAK

Dr. Daniel Blain, Chief of the Neuropsychiatric Service of the United States Veterans Administration, is to be the principal speaker at a public meeting sponsored by the Mental Health Committee of the Tulsa Council of Social Agencies, and presently scheduled for Tuesday, December 9, 1947.

Dr. Blain's appearance here is one in a series devoted to scientific and lay discussions of mental health and sponsored by the Council and cooperating agencies. 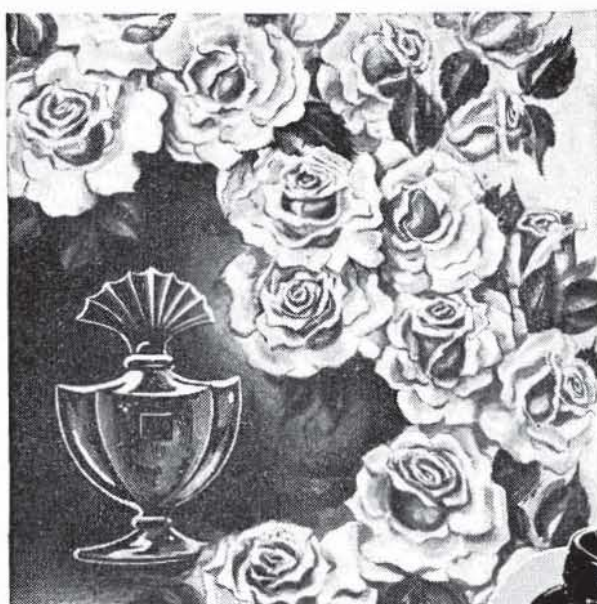

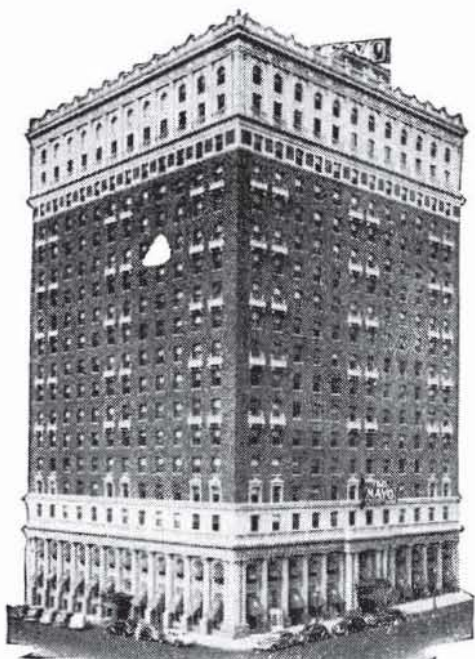
