

# PETER G. MURRAY, M.D. 1880 - 1952

Dr. Peter G. Murray, 72, pioneer Tulsa physician, died at his home on August 25, 1952, a victim of cancer.

Born in 1880 at Sedgewickeville, Missouri, he attended Marvin College at Fredricktown, Missouri, and in 1905 was graduated from Barnes Medical College, St. Louis. He practiced for five years at Patton, Missouri, and for eleven years at Thomas, Oklahoma, before coming to Tulsa in 1921. Dr. Murray was the second physician to pass the medical licensure examinations after Oklahoma became a state in 1907. Since coming to Tulsa he specialized in obstetrics and gynecology, delivering approximately 200 babies each year. He was a member of the Tulsa County Medical Society and for many years was in charge of the Society's annual golf tournament. An excellent golfer, he won many amateur trophies.

We are adopting in every bracket of our social existence a philosophy of dependence, a practice of group collective action. The farmer subsidized, the teacher subsidized and used as the instrument of communistic indoctrination, the doctor and hospital practicing and teaching socialism through welfare quasi charitable nuclei of clinics. Nurses aiding and abetting, the U.S.P.H. agitating and promoting, the government financed home owner, government bureaucratic employment, the W.H.O. and the I.L.O. #### OKLAHOMA CITY INTERNIST TO SPEAK HERE OCTOBER 13

Dr. Stewart G. Wolf, Jr., newly appointed Professor and Head of the Department of Medicine at the University of Oklahoma School of Medicine, Oklahoma City, will be guest speaker for the Tulsa County Medical Society on Monday, October 13, 1952, at 8:00 P.M. at The Mayo. His subject will be "Peptic Ulcer—Evidence for Pathogenesis and Rationals for Treatment."

A native of Baltimore, Maryland, Dr. Wolf attended Phillips Academy, Andover, Yale University, and Johns Hopkins University, receiving both his A.B. and M.D. from the latter school. He served his internship and a medical residency at New York Hospital, New York, N.Y., and later was a research fellow at Bellevue Hospital, New York, and at the Harvard Neurological Unit of Boston City Hospital, Boston, Massachusetts. During World War II he served as a Major in the Army Medical Corps, seeing service with the Ninth General Hospital unit in the South Pacific. In recent years he has been Associate Professor of Medicine at Cornell University School of Medicine.

Dr. Wolf has authored 79 scientific articles published in national medical journals, four monographs, and has contributed material to five books. His research activities have included the fields of gastrointestinal physiology, diabetes, and cardiovascular diseases. In 1943 the American Gastroenterological Association awarded him its Distinguished Research Award.

On November 10, 1952, members of the Tulsa County Medical Society will hear Mr. Samuel Alfend, Chief of the Kansas City District, United States Food and Drug Administration, Kansas City, Missouri, in a lecture entitled "The Nostrums and Quackery Encountered by the Federal Food & Drug Administration."

The program of December 8, 1952, will be devoted to annual committee reports and election of officers for 1953. The first program of 1953 will be on January 12, at which time Dr. J. Garrott Allen, Professor of Surgery at the University of Chicago School of Medicine, will be guest speaker.

#### CLINICAL SOCIETY TO MEET

The 22nd Annual Conference of the Oklahoma City Clinical Society will be held October 27-30, 1952, at the Biltmore Hotel, Oklahoma City. Seventeen nationally known visiting distinguished guest speakers will highlight the program. Complete details appear in the advertisement on Page 25.

#### **EDITORIAL**

#### A TIME FOR PLANNING

A Sunday afternoon drive through the lengthening outskirts of Tulsa can leave no doubt about the fast pace at which our City is growing. Where complacent cows grazed in meadowlands only a few weeks ago, now whole communities of homes and stores have sprung up. The same displaced cows are constantly beset by surveyors in their midst as plans for the next sub-division or community shopping center shape into being. Tulsans are happy about this mushroom growth; most of it is attributable to a high level of employment opportunities, which in turn open up expanding fields of commercial endeavor. The net result is a high standard of living in stable industry, an essential economic factor in the success or failure of any community. The prognosis is highly favorable.

There is a tendency in such times of rapid expansion for the elements of growth to get out of balance. Over-crowded schools, lack of sewer and sanitary facilities in many new areas, and inadequate downtown parking to serve the hordes of automobiles are typical examples. Naturally, it is difficult to plan in advance for such things, but once the definite needs have been clearly established it is essential that positive and well developed planning be inaugurated to correct these deficiencies.

What concerns Tulsa concerns Tulsa Medicine and the Tulsa County Medical Society. We should like to see our community develop along sound well balanced lines. There are a few specific suggestions which we should like to make, not in the nature of criticisms but as information helpful to our civic and government leaders. Accompanying these suggestions is our pledge of cooperation in any efforts which will be made by the community as a whole to bring these suggestions into being. It is only by a community-wide cooperation that things can be attained.

Tulsa Medicine has most concern for

its children and their schooling. The long-range plans of the Board of Education are excellent, but every effort should be made to see that these plans are carried into prompt execution. Schools must be numerically and physically adequate, faculties must be qualified and large enough to meet the enrollment. This is one place where we cannot be niggardly. The whole future of the nation depends in large measure upon our children.

We should like to see the installation of a sewage disposal plant, elimination of faulty septic tanks, and extension of sewers in all areas. The smelly Arkansas River and its accumulations of rotting sewage in times of drouth adds another health hazard to Tulsa. The spectre of the polio epidemic will always loom large until this situation is corrected.

The Civic Center for Tulsa continues to be but a dream although bonds are voted and plans are made—but nothing happens. Doddering old Convention Hall. centered in the middle of the railroad tracks, reminds us that our cultural facilities are fully thirty years behind the times. We are expected to be satisfied with an inane plan to spend a few thousand dollars on a new foyer for the "Old Lady Of Archer." And so, the Metropolitan Opera plays Oklahoma City, the Broadway touring companies make Little Rock, the concert artists sing at Wichita. For Tulsa is left but the poorest crumbs, all for want of a decent auditorium.

Parking surveys come and go, but the construction of adequate downtown parking facilities are few. Chug-holes pockmark the unpaved streets in many of our best and most of our poorer residential areas. A multi-million dollar bridge of shining steel and concrete spans the Arkansas River at 51st Street, useless because the city and county governments have neglected to build approaches. Conventions shy away from Tulsa for want of adequate meeting facilities. Our public library years ago outgrew its physical facilities. Dangerous intersections pose a constant hazard to life and limb for want of traffic signals. Our city and county governments follow outmoded methods of operation which promote waste and

(Continued From Page 16) inefficiency; many of the obvious, common-sense suggestions of the Griffenhagen Report are scorned because they threaten the identities of many city units. Dirty, ill-kempt Mohawk Park is a disgrace.

A Master-Planning Committee with an aggressive, objective program is highly desirable. Some steps were made in this direction in recent years but the plan is presently dormant. Careful planning of city growth can eliminate many of these problems and result in a more livable, enjoyable, beautiful city. Tulsa, like Topsy, "just growed" into its present stature. It is not a healthy pattern of progress.

It is not often that these editorial columns deviate from medical matters, but as doctors we are citizens and as citizens we have a civic responsibility. Let's work together to keep Tulsa apace with other cities in all respects. Let's keep it head and shoulders above our neighbors and always in the vanguard of progress.


