





NEW MALPRACTICE MASTER POLICY SET

St. Paul-Mercury Indemnity Company Writes New Protection For Oklahoma Doctors. Basic Premium Set At \$52.00 Per Year.

The Oklahoma State Medical Association late last month announced completion of arrangements for a new official master policy of malpractice insurance for its members to be written by the St. Paul-Mercury Indemnity Company of St. Paul, Minnesota. The new policy replaces the one formerly held by the London and Lancashire Company and cancelled without satisfactory explanation last April 1st.

The St. Paul-Mercury policy is effective immediately and Tulsa and other Oklahoma doctors may purchase the protection under terms of the master policy at once.

The new program will work in the same manner as the previous program with the London and Lancashire Company. Protection under the master policy will be limited to members of the State Association with clearance by local committees in each county. The Company may decline any application, however, if the applicant does not meet established underwriting principles of the Company.

The St. Paul-Mercury master policy, in contrast to the London & Lancashire policy, does not offer separate coverage for medicine and surgery. A basic policy of minimum limits of \$10,000-\$30,000 is written for both medical and surgical coverage at an annual premium of \$52.00 Extended coverage, which is highly recommended, is available at graduated rates. For basic coverage the premium is considerably higher than the London & Lancashire rates, but for extended coverage premium rates are actually lower. Differentials in premiums are required for coverage of physicians using x-ray, for plastic surgeons, and psychiatrists doing shock therapy. The Company also reserves the right to assess an additional premium for physicians or groups employing a large number of nurses, technicians, and other medical assistants.

The same legal talent and advisory legal service will represent the St. Paul-Mercury policy as represented previous master policy-holders in the last thirteen years. Any policy-holder who has a situation which may develop into a suit is required to put the Company on notice by writing to either the agent or to the Company offices. Details of this procedure can be obtained from the Executive Secretary of the Tulsa County Medical Society. Stress is laid upon policy provisions requiring written notice of suit or possible suit.

Complete details of the new program were sent to all members of the Oklahoma State Medical Association by letter dated July 24, 1952.

The agents for the St. Paul-Mercury Indemnity Company in Tulsa County are Rich & Cartmill, the Howard Company, Philip Kramer, and Alexander & Alexander. Many other individual agents offer the policy for sale by brokering it through the general agents. Physicians are advised to make inquiry of the agent of whom they wish to do business. Premium rates are uniform.

The St. Paul-Mercury Indemnity Company will also offer hospital coverage and individual property damage and public liability coverage, although the latter is not required.

The new master policy was developed by the Insurance Committee of the Oklahoma State Medical Association.

WHAT'S GOING ON IN THE TULSA COUNTY MEDICAL SOCIETY?

A Summary Of Recent Activities

What's going on in the Tulsa County Medical Society? Despite temperatures in the mid-90's and many members away on summer vacations the Society has continued with a full program of work. Here's a run-down of recent activities by the Society's committees and the Executive Offices:

Already at work on plans for the 60th Annual Meeting of the Oklahoma State Medical Association in Tulsa, April 12-15, 1953, are Dr. Gifford H. Henry, General Convention Chairman, and Dr. Berget H. Blocksom, Chairman of the Scientific Works Committee. Five distinguished medical personalities have already been secured as guest speakers and Dr. Blocksom expects to complete the scientific program, which will include papers, motion pictures, roundtable forums, and possibly color television, by December 31st. The prospectus for commercial exhibitors goes out in about 60 days. As in the past the Tulsa County Medical Society will handle all arrangements for the meeting. Dr. Henry expects to appoint additional convention officials this month. Due to the International Oil Exposition being held in Tulsa next May, doctors must advance their meeting a month earlier than the usual date . . . Dr. Robert E. Funk's Clinic Committee has been cooperating with the Health Division of the Tulsa Council of Social Agencies in a detailed study of the Tulsa County Medical Clinic. The survey, completed but still under study by a supervisory committee, is expected to develop more efficient methods in Clinic administration. To insure accuracy and a complete picture of Clinic operations, Dr. Funk and his group met on four occasions with Council survey officials in hours-long discussions . . . Dr. John E. McDonald is heading up a new liaison committee with the Tulsa Chamber of Commerce. An eleven-point program, developed in cooperation with a special committee headed by Chamber President

Verser Hicks, seeks greater active participation in civic affairs by Tulsa doctors. Continuation of the annual Doctor's Day at the weekly Chamber Forum luncheons has been set with the next tentatively scheduled in March. The Society will get a complete story of Committee plans at the first Fall meeting on September 8th . . . Dr. Joseph Fulcher and his six-man Telephone Committee have been studying various methods of specialty listings in the classified section of the telephone directory. To determine likes and dislikes about the present method the Committee members presonally interviewed fifty per cent of the members. Replies to five basic questions have been tabulated, along with many suggestions about the listings, and will be reported to the Society with recommendations at an early Fall meeting . . . Dr. A. B. Carney's Hospital Relations Committee has been studying various private hospital insurance plans in an effort to determine how widespread the practice of paying for diagnostic services in hospitals has become. The Committee recently secured approval of the Board of Trustees to protesting to the Council of the Oklahoma State Medical Association of such practices. Committee seeks either elimination of this form of hospital practice or the granting of such privileges in the private offices of all doctors . . . The Medical Credit Bureau continues to make strong gains, both in the volume of monthly collections and the number of clients served. The latter has reached 140 doctors, dentists, and clinics. Dr. Berget H. Blocksom's supervisory Medical Credit Bureau Committee is now attempting to add some fifty Tulsa doctors not now using the service to the list of regular clients. Collections for 1952 are up over 400 per cent over the same period in 1948, a scant four years ago . . . The Medical Library Committee and Dr. David V. Hudson, in particular, have been developing the Medical Library Endowment

Fund. A number of small endowment funds established years ago for the Library have been consolidated into a single endowment. Many recent gifts from lay persons and doctors alike have been invested in shares of group investment funds with dividends to be used in increasing endowment principal or in the purchase of journal subscriptions. The Library has also been experiencing a record patronage by doctors and other authorized users . . . The Board of Trustees of the Tulsa County Medical Society huddled with the Tulsa City-County Board of Health on June 18th on plans for a new system of venereal disease treatment centers in Oklahoma. The Board okayed participation by the City-County Health Department in a new plan which will create a regional center at Tulsa operated in cooperation with United States Public Health Service officials . . . The Board of Trustees also participated in an evaluation of the Tulsa Child Guidance Clinic conducted by the Tulsa Council of Social Agencies. The Board rated the Clinic of top community value, recommended its continuation, and threw a bocquet to the Clinic Medical Director, Dr. Paul C. Benton . . . The Program Committee is winding up its work for 1952 with the setting of Mr. Samuel Alfred, United States Pure Food and Drug Administration official of Kansas City, as speaker for the November 10th meeting. Dr. Edward L. Moore has been added to the Program Committee personnel for 1953, succeeding Dr. Albert W. Wallace, who retires after three years of service. The Committee begins assembly of the 1953 schedule of scientific programs early in August . . . Dr. Fred E. Woodson's Insurance Committee is busy with local arrangements for establishing the new St. Paul-Mercury Indemnity Company's master policy of malpractice insurance in Tulsa County. For complete details of this activity see Page Seven of this issue of The Bulletin . . . Dr. W. A. Showman's Building Committee met recently with Tulsa real estate officials to learn some surprising and intricate details of real estate financing. Entrusted with the problem of finding some solution to the Society's acute housing problem, the Committee seeks to establish some plan

of financing preparatory to purchase of suitable building sites or structures . . . Dr. Felix R. Park's Red Cross Blood Center Committee met recently to evaluate the new medical standards governing the acceptance of blood donors as instituted early this year (and reported in detail in the April issue of The Bulletin). Satisfied with results of the first three months, the Committee voted to extend the trial period for the balance of the year. Also okayed were Red Cross plans to hire a full-time Blood Center Administrator whose principal duties would be in recruitment. Post has been vacant since the resignation of Mrs. Ruth S. Wells last May. Committee also directed continuation of efforts to locate a regional blood center in Tulsa . . . With its Review of General Medicine postgraduate course, conducted during the Spring months, now completed, the Postgraduate Study Committee reported average attendance at 25. Figure came as a disappointment to Committee officials who considered quality of papers by visiting lecturers excellent. Dr. Henry A. Brocksmith, Chairman, said last month the Committee hoped to sponsor a similar course of study this Fall . . . Progress towards the establishment of a code of cooperation between medicine and the press has been made by Dr. John E. McDonald's Press Relations Committee. Working with representatives of the Tulsa World, Tulsa Tribune, and Tulsa Association of Newscasters, as well as administrators of local hospitals, the Committee's several meetings have produced marked results in improving press-medicine relationships. Another meeting of the group, to be held in August, is expected to establish a workable system of news contacts at local hospitals . . . Three proposed amendments to the Constitution & By-Laws are undergoing revision at this time by the Constitution & By-Laws Committee and are expected to be presented to the membership for ratification in December. Most of the changes are designed to strengthen committee structure . . . In other routine activities, the Society's Executive Offices continues to answer dozens of calls from the public about medical services in Tulsa and elsewhere, publishes






