

Author/Copyright Owner Agreement for UCO Contributions to SHAREOK

By signing this document, you, the author or copyright owner, grant University of Central Oklahoma Chambers Library, hereafter designated as UCO Chambers Library, the non-exclusive right to reproduce, translate (as defined below), and/or distribute your submission (including the metadata and abstract) worldwide, in any format or medium for non-commercial, academic purposes only in SHAREOK. SHAREOK is the joint institutional repository for the University of Oklahoma Libraries (OU), Oklahoma State University Libraries (OSU), and the University of Central Oklahoma Max Chambers Library (UCO). It serves as the home for the intellectual output of those institutions.

By accepting this agreement, you, the author or copyright owner, retain the copyright to the submitted work and do not give up the right to submit the work to publishers or other repositories. UCO Chambers Library will clearly identify your name(s) as the author(s) or owner(s) of the submission, including a statement of your copyright, and will not make any alteration, other than as allowed by this agreement, to your submission.

To properly administer SHAREOK at UCO and preserve the contents for future use, UCO Chambers Library requires certain permissions from you, the author or the copyright owner:

1. You agree that UCO Chambers Library may, without changing the content, translate the submission to any medium or format and keep more than one copy for the purposes of security, back up and preservation.
2. You also agree that authorized readers of your work have the right to use it for non-commercial, academic purposes as defined by the "fair use" doctrine of U.S. copyright law, so long as all attributions and copyright statements are retained.
3. You represent that the submission is your original work, and that you have the right to grant the rights contained in this agreement. You also represent to the best of your knowledge that your submission does not infringe upon anyone's copyright. You also represent and warrant that the submission contains no libelous or other unlawful matter and makes no improper invasion of the privacy of any other person.
4. If the submission contains material for which you do not hold copyright and that exceeds fair use, you represent that you have obtained the unrestricted permission of the copyright owner to grant UCO Chambers Library the rights required by this agreement, and that such third-party owned material is clearly identified and acknowledged within the text or content of the submission.

The repository is meant to be a permanent scholarly record once a paper is deposited. Removing content is discouraged; however, content may be removed from the SHAREOK at UCO under certain circumstances. Reasons for removal may include copyright infringement, plagiarism, or falsification of data.

Updated versions of content may be posted, and can be linked to the first posted version. Earlier versions may be removed at the author(s) request. Regardless of an author's continued affiliation with the university, their material will remain in SHAREOK. At their request, new contact information can be added to their files.

IF THE SUBMISSION IS BASED UPON WORK THAT HAS BEEN SPONSORED OR SUPPORTED BY AN AGENCY OR ORGANIZATION OTHER THAN UCO CHAMBERS LIBRARY, YOU REPRESENT THAT YOU HAVE FULFILLED ANY RIGHT OF REVIEW OR OTHER OBLIGATIONS REQUIRED BY THAT CONTRACT OR AGREEMENT.
