In accordance with the University of Oklahoma travel reimbursement policy, reimbursements for travel related expenditures can only be made for expenses documented with itemized receipts. Hard-copy receipts are preferred, although copies may be accepted. For purchases secured either online or with a travel agent, please submit a copy of both your travel itinerary and your receipt. If you are driving to the conference, University of Oklahoma policies allow reimbursement up to \$0.54 per mile.
